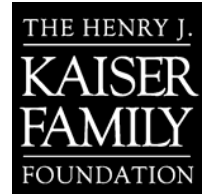

Methodology

The Kaiser Family Foundation *National Survey of the Public's Views about Medicaid* was designed and analyzed by researchers at the Kaiser Family Foundation. Fieldwork was conducted by telephone by Princeton Survey Research Associates between April 1 and May 1, 2005, among a nationally representative random sample of 1,201 respondents 18 years of age and older. Results have been weighted to be representative of the U.S. population by sex, age, education, race, Hispanic origin and region.

The margin of sampling error for the survey is plus or minus 3 percentage points for total respondents. For results based on subsets of respondents the margin of error is higher. Note that sampling error is only one of many potential sources of error in this or any other public opinion poll.

Near the beginning of the survey, but after basic knowledge questions were asked, all respondents were read the following common definition of Medicaid: “Medicaid is a government program for low-income people whose costs are shared by both the federal government and state government. It provides health insurance and long term care assistance to eligible children and their parents, elderly, and people with disabilities.” For complete question wording, please see the survey topline document.

Percent who say each is very important ...

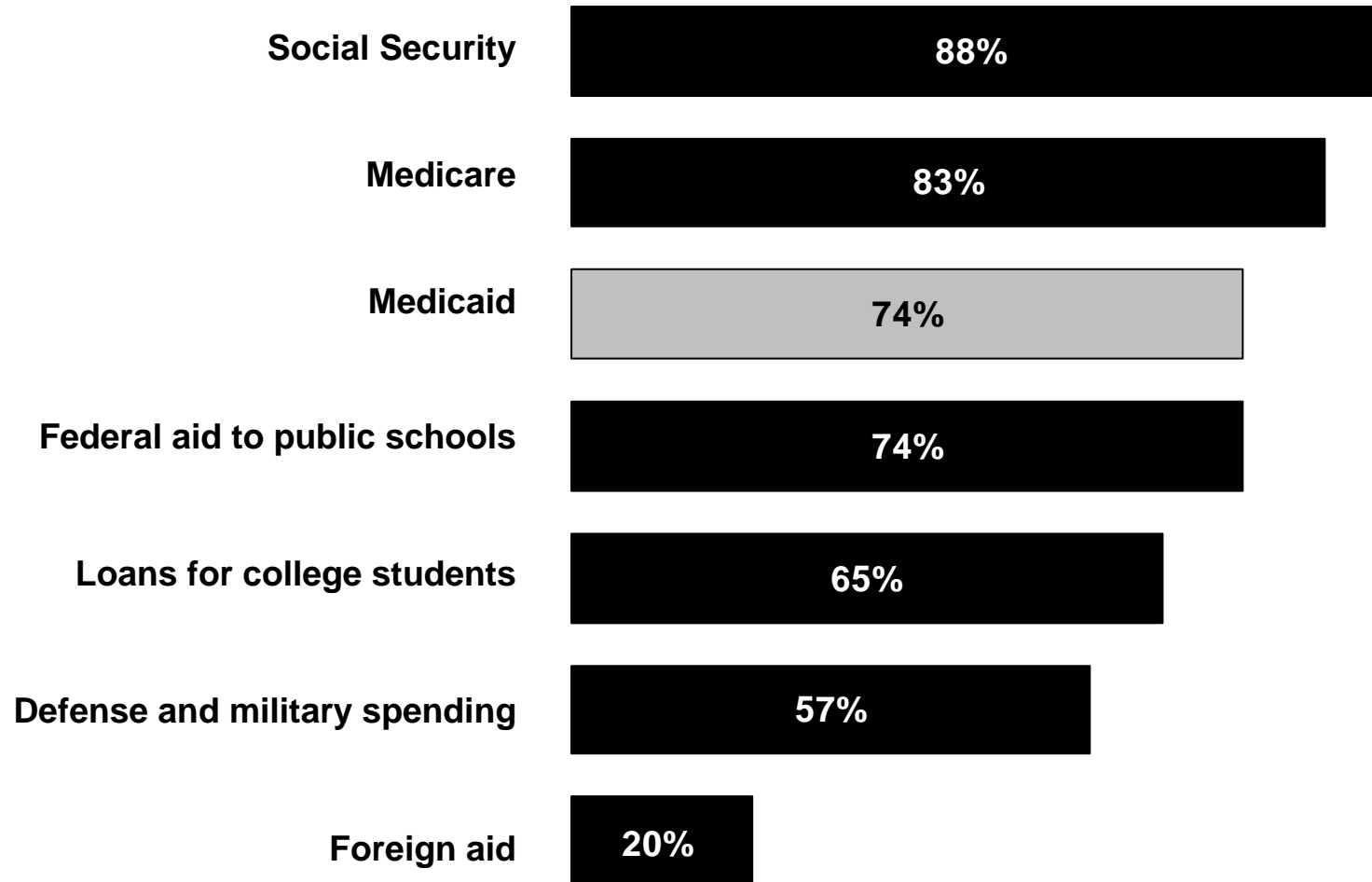
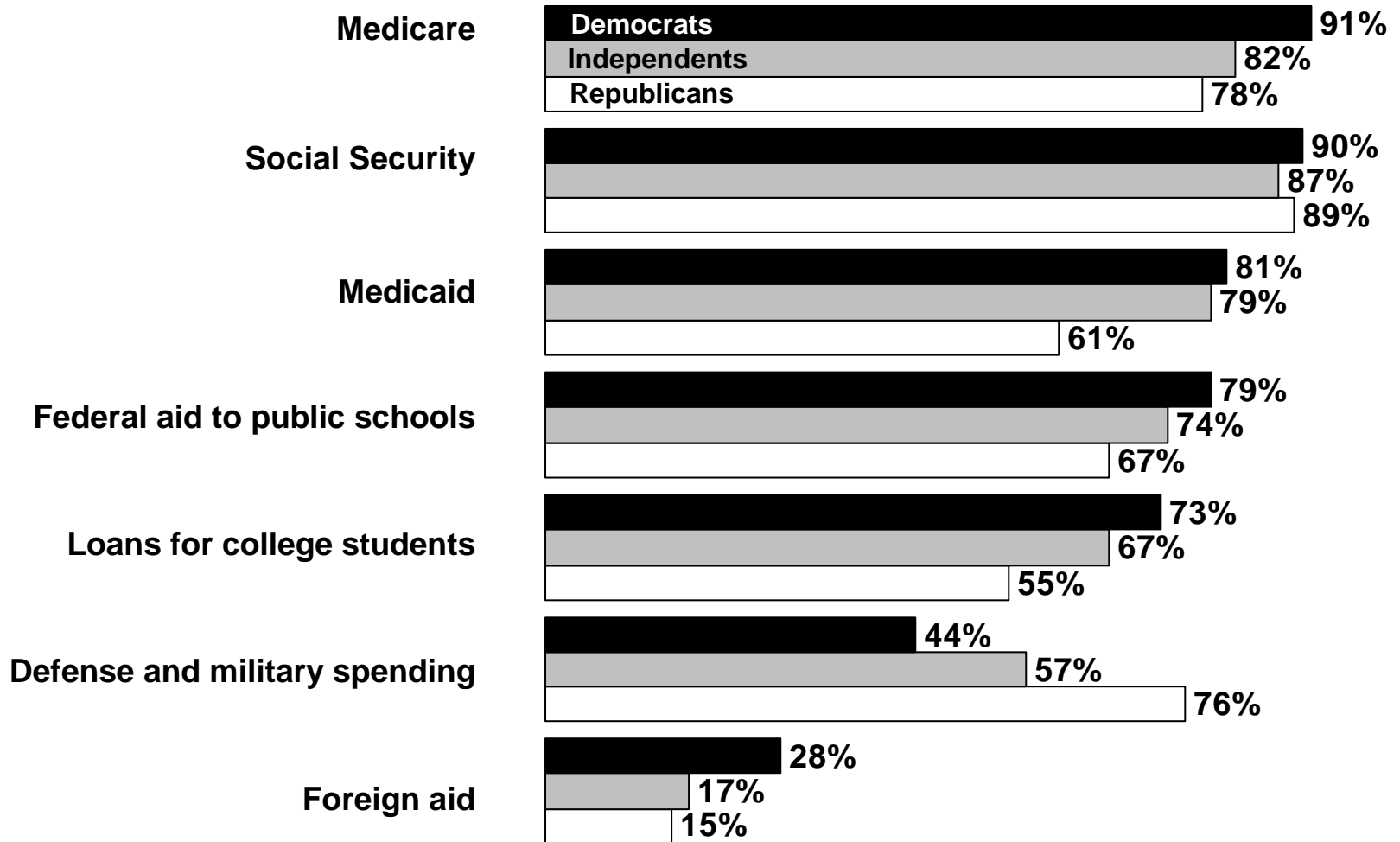

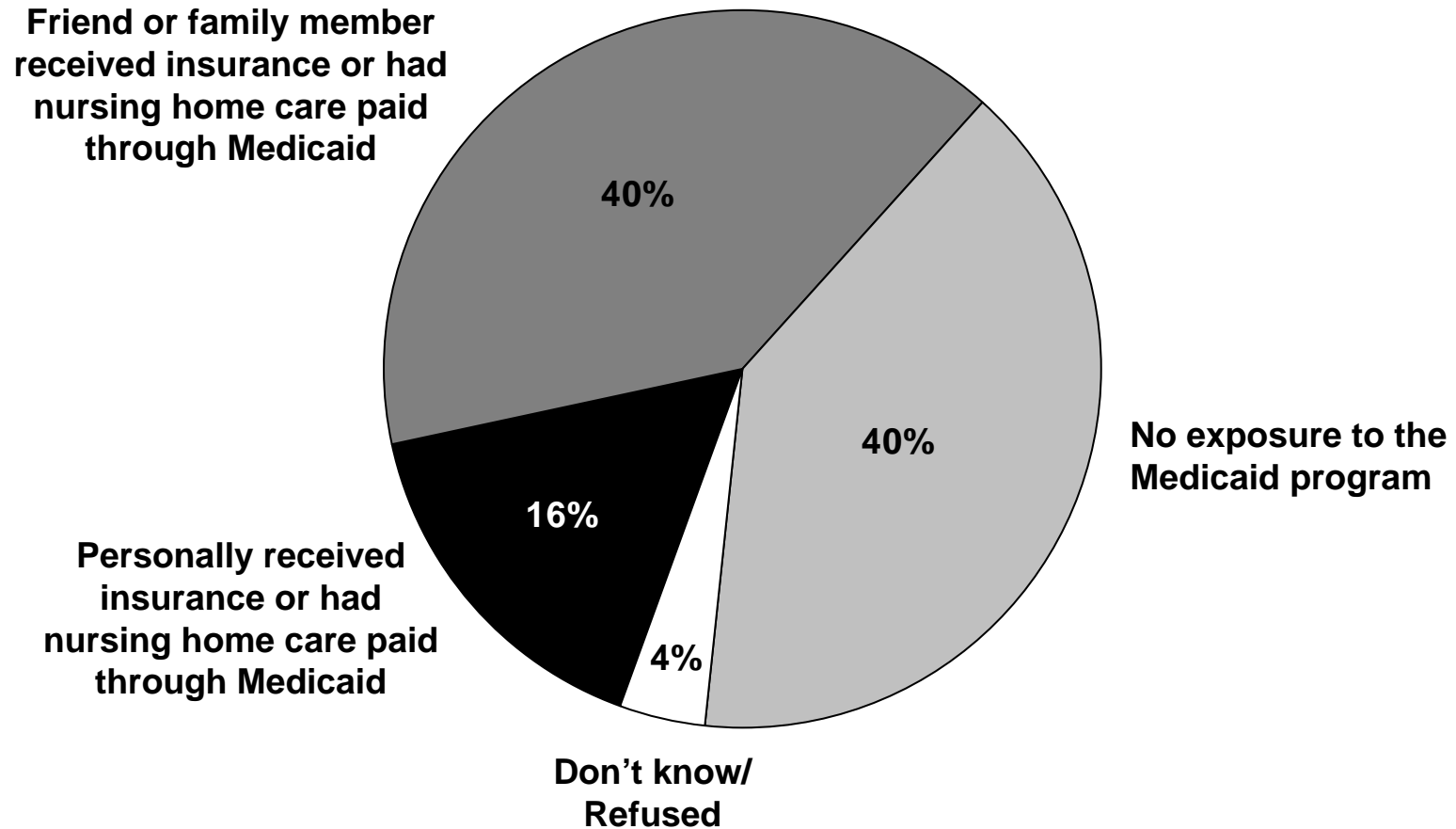

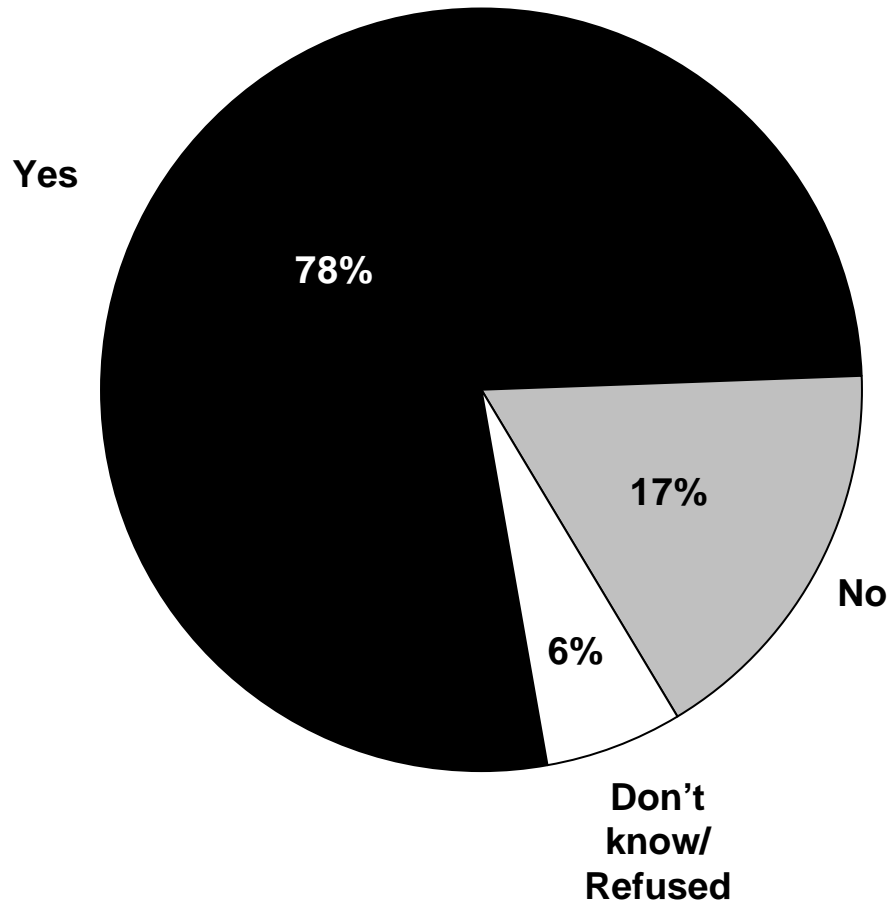

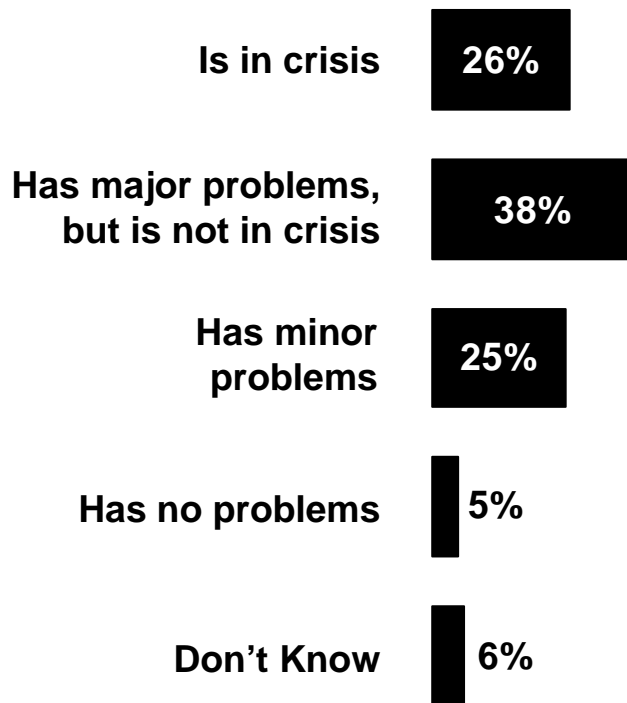
Willingness to Enroll in Medicaid?

If you needed health care and qualified would you enroll in the Medicaid program, or not?

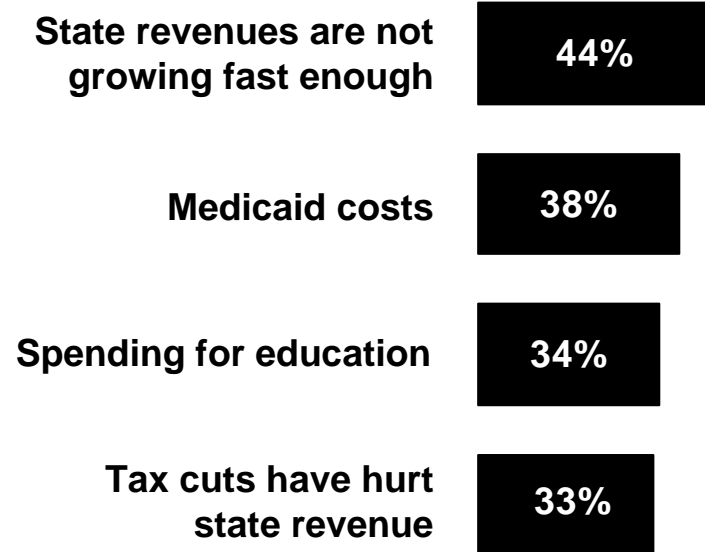


State Budget Problems

Which of the following four statements comes closest to your own view of the budget in your state? The budget...



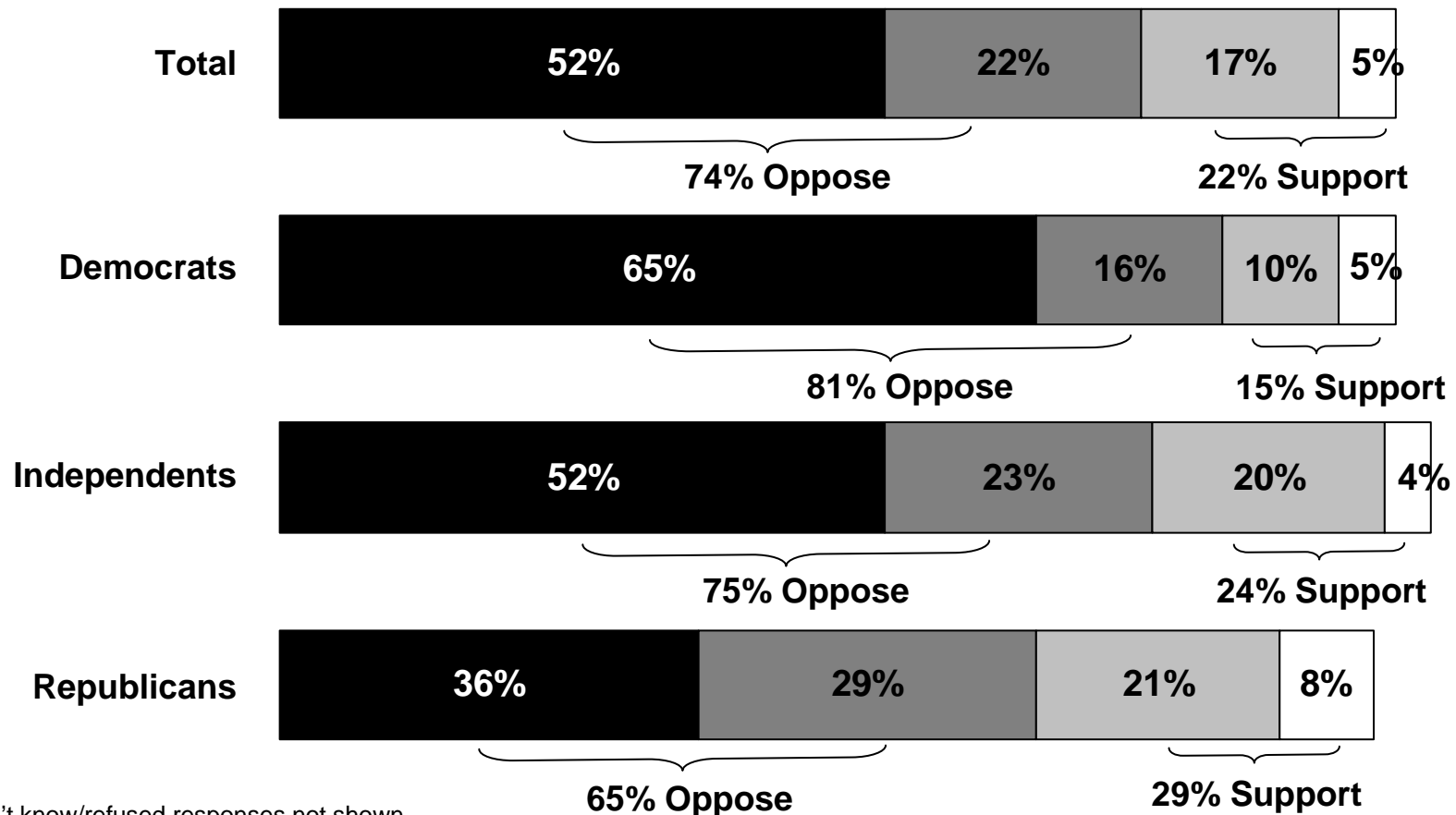
Among those who say their state budget is in crisis or has problems (90% of the public), the percent who say each is a major reason their state is having problems with its budget..

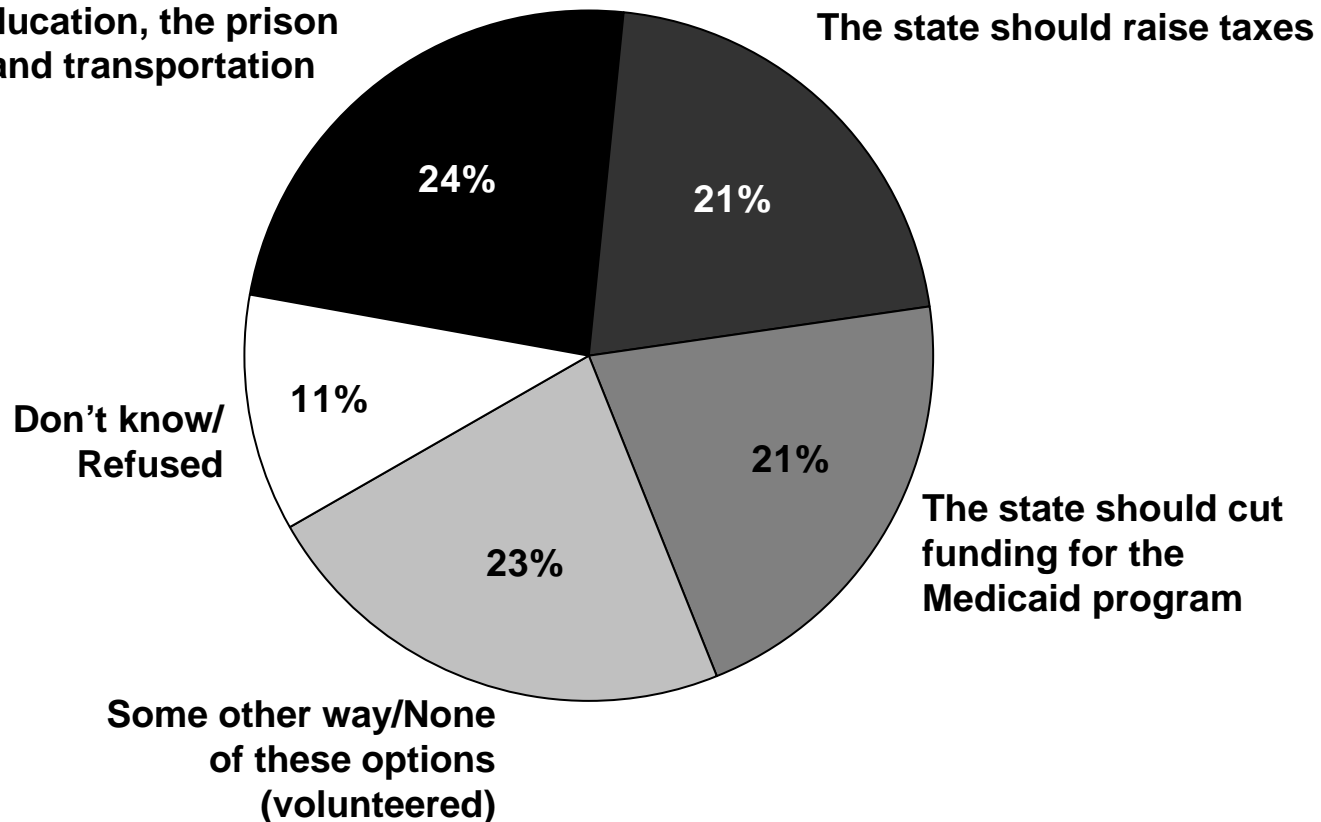

Which one of the following is the best way for your state to reduce its budget problems? (Asked of half sample)

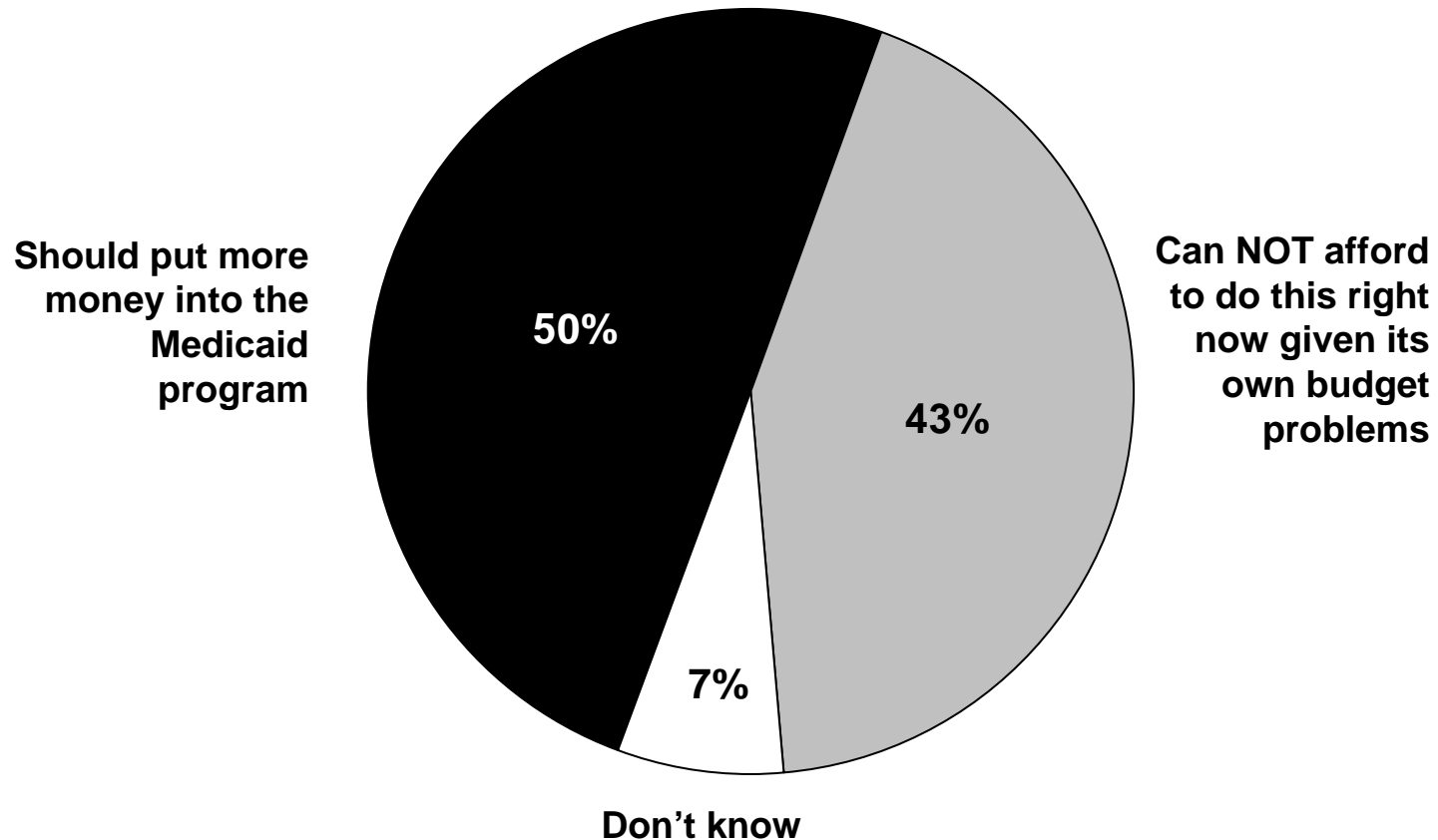
The state should cut funding for programs other than Medicaid such as education, the prison system, and transportation

The state should raise taxes



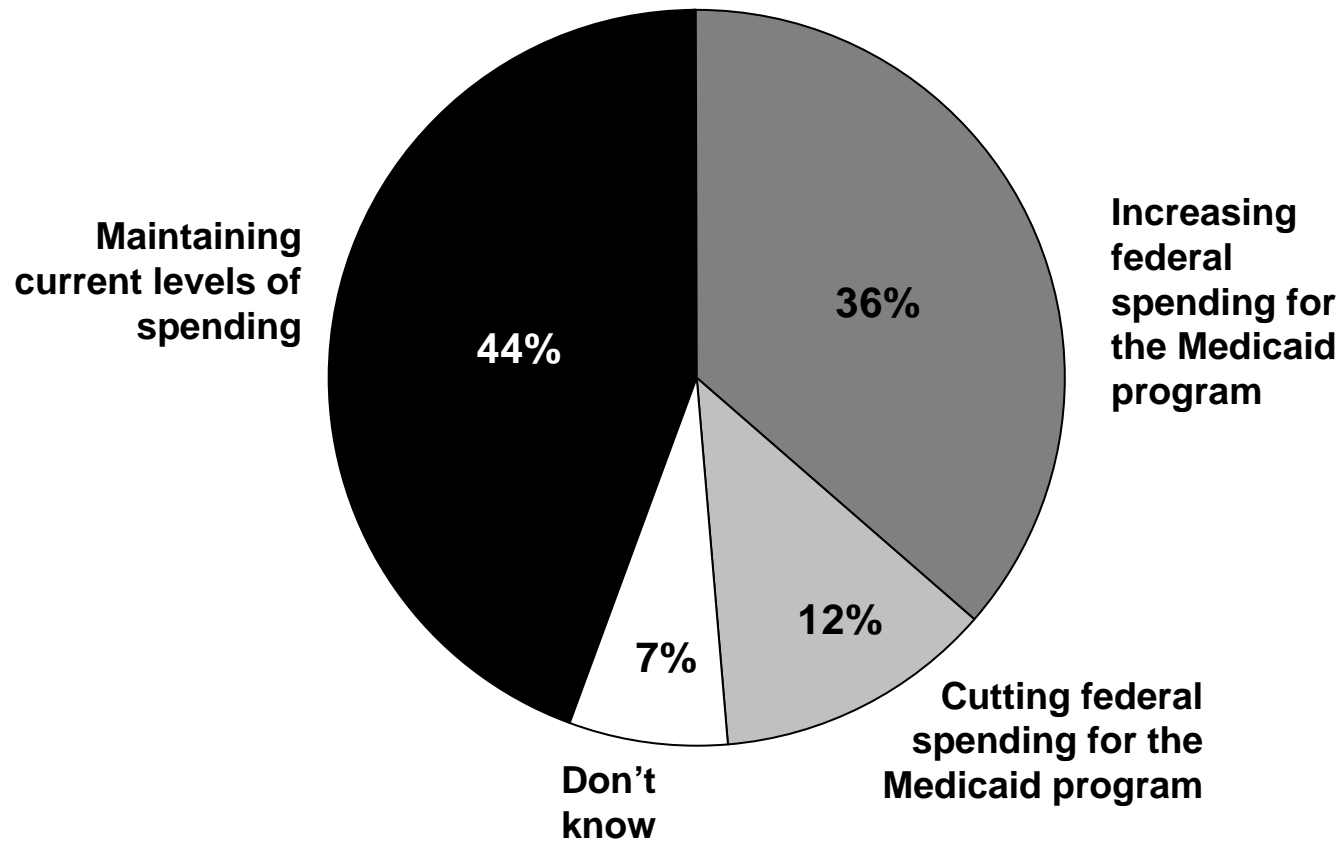
Federal Spending on Medicaid

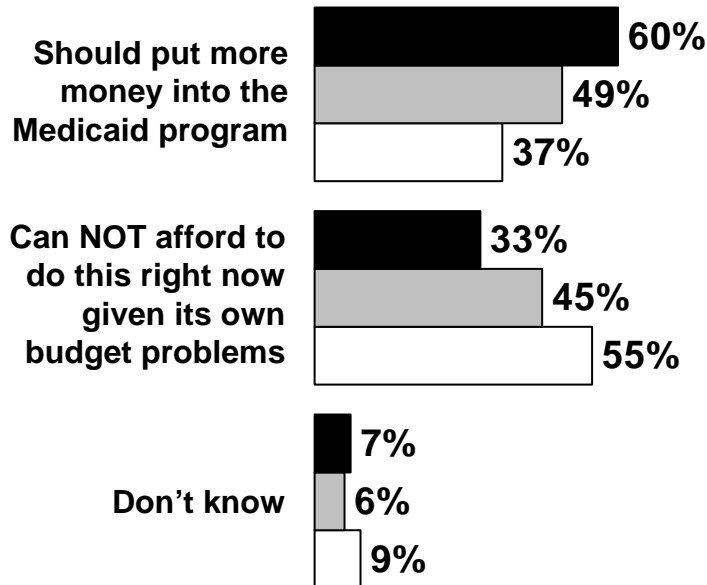


Federal Spending on Medicaid By Political Party Self Identification

■ Democrats ■ Independents □ Republicans

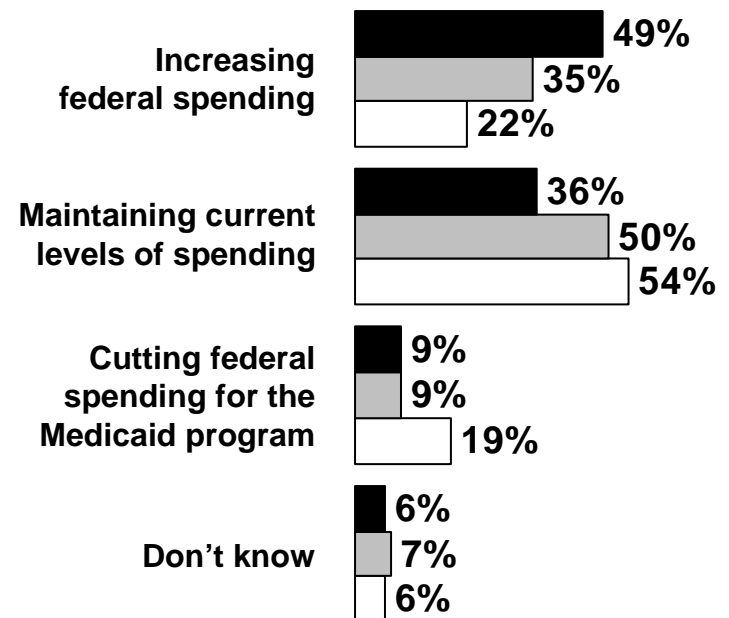
Given state budget problems do you think the federal government should put more money into the Medicaid program, or do you think the federal government can NOT afford to do this right now given its own budget problems?

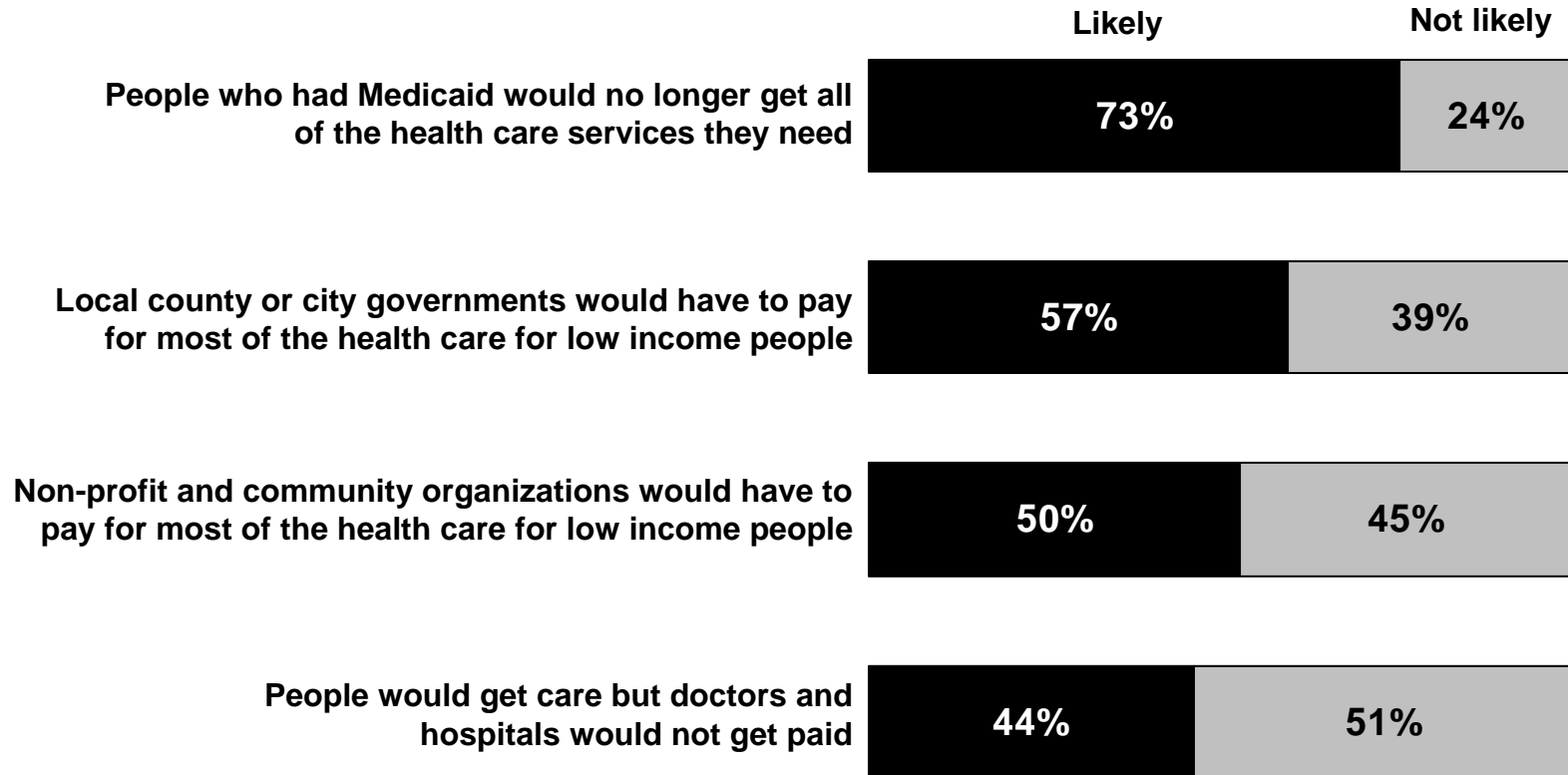
In the federal government, the House of Representatives has proposed cutting the amount of federal funding for Medicaid, while the Senate has not proposed cuts. Which approach would you prefer?

If states were forced to cut Medicaid spending to balance their budgets, do you think each of the following would be likely or not?

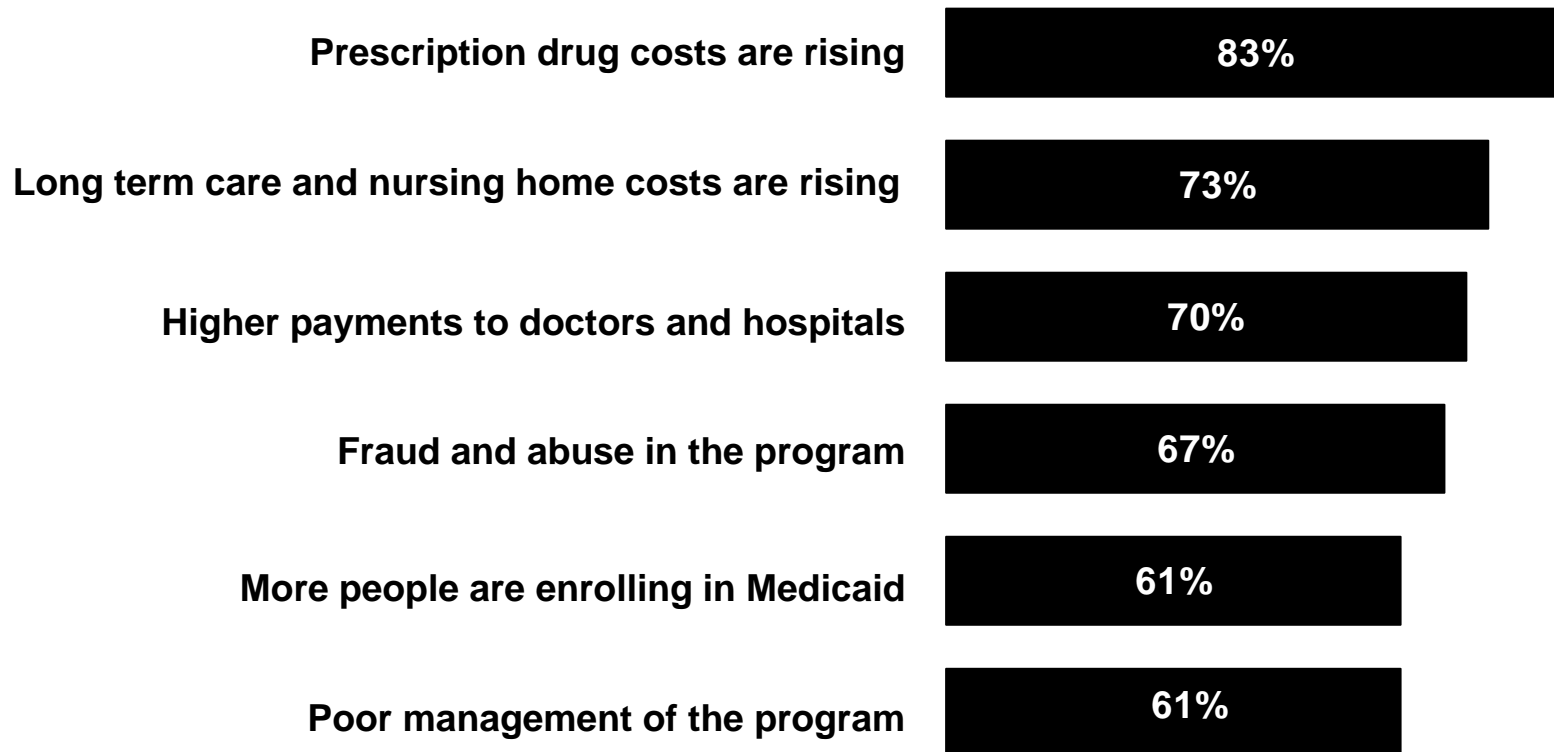

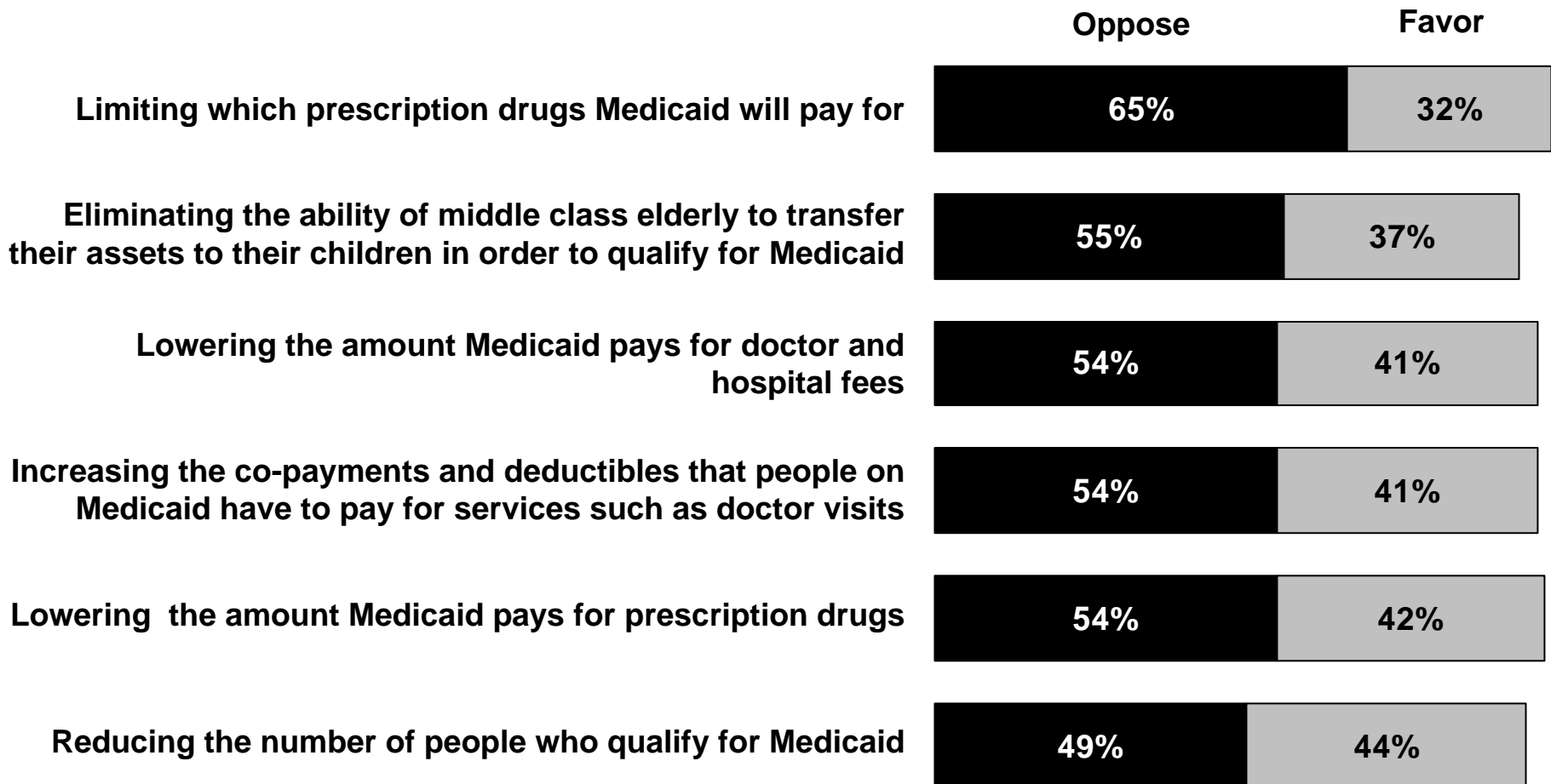
Perceptions About Why Medicaid Spending Is Increasing

Percent who say they would favor or oppose each proposal in order to deal with the financial problems of Medicaid...

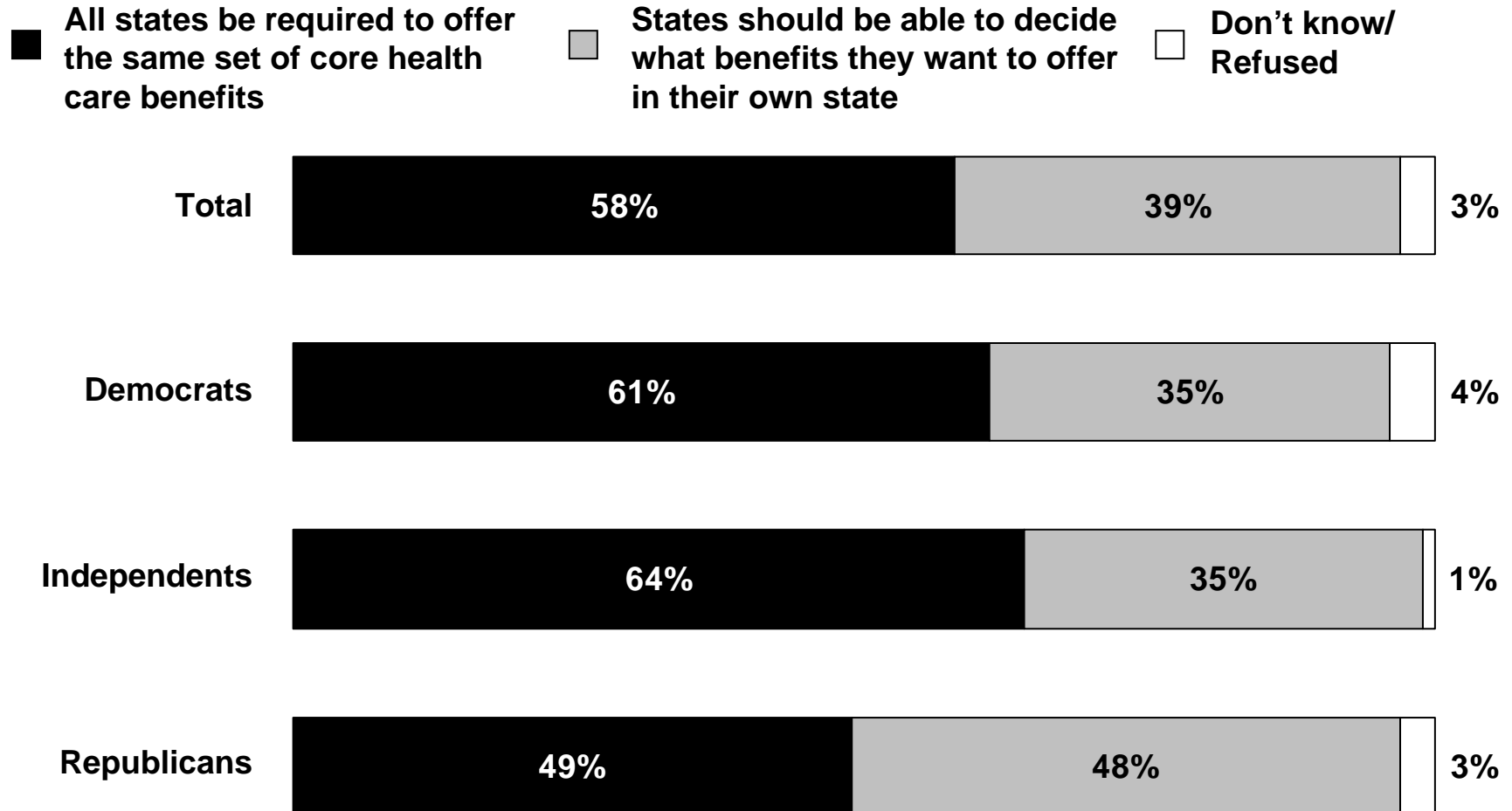

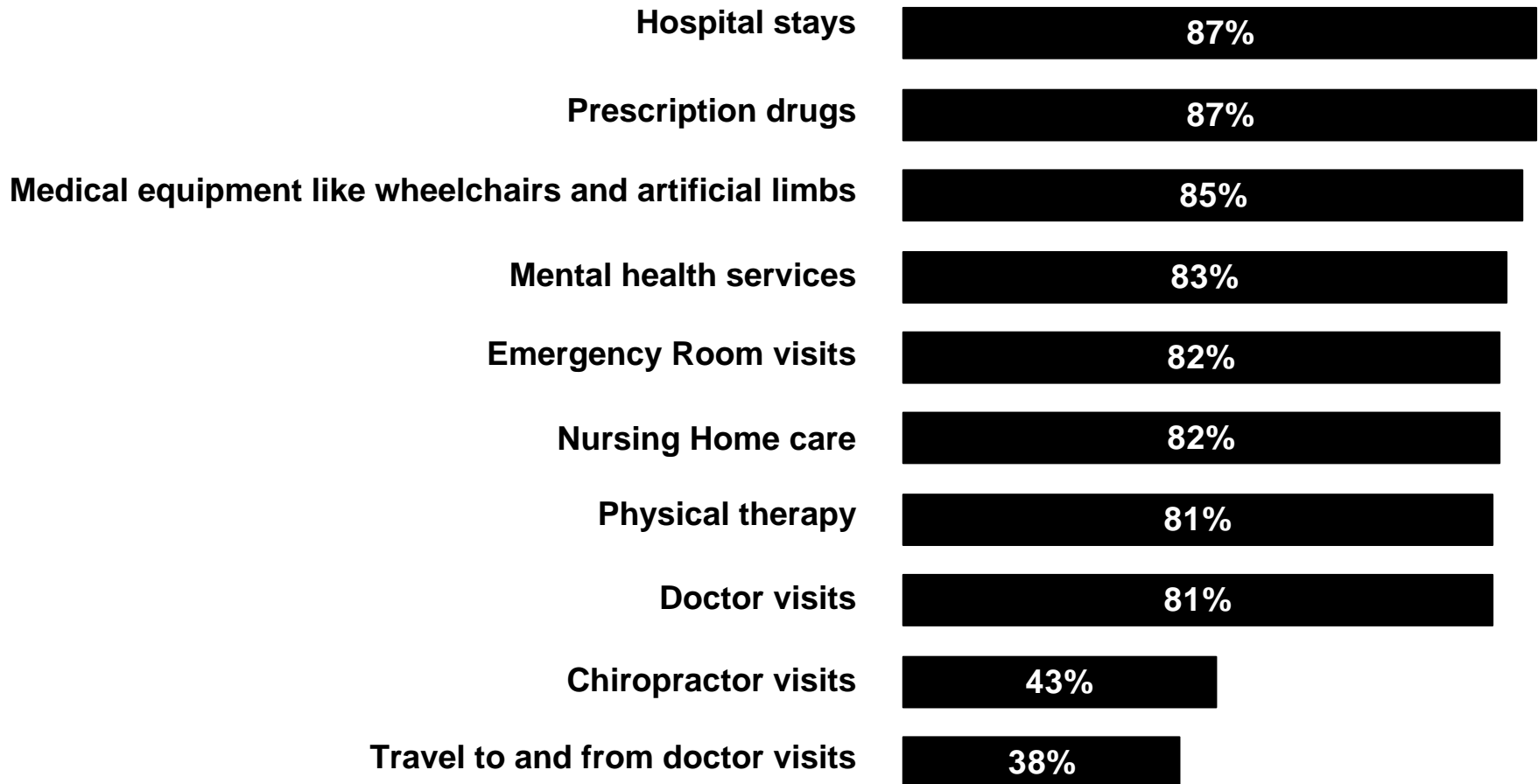
State Flexibility on Benefits

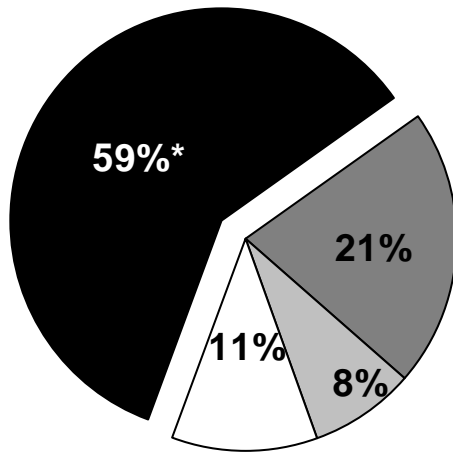

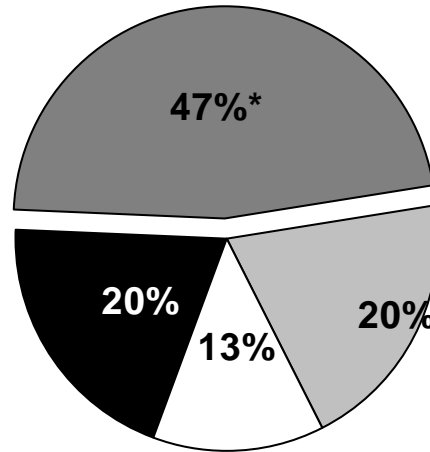

Which of the following government programs is the primary source of health insurance for...

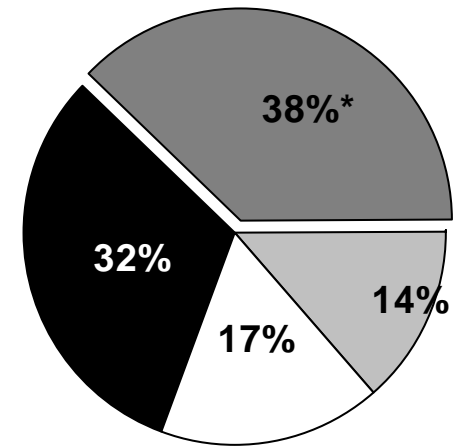
People over 65 regardless of their income

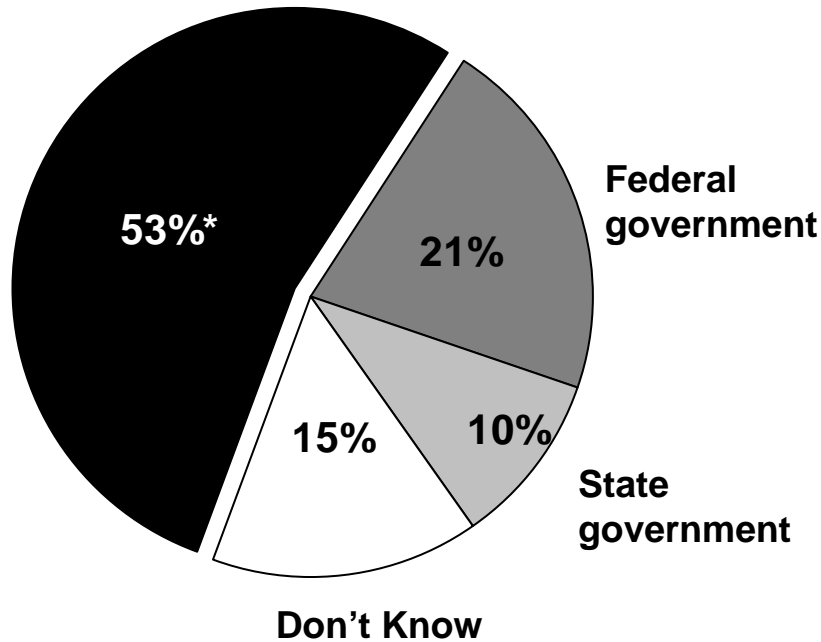

Who currently funds the Medicaid program?

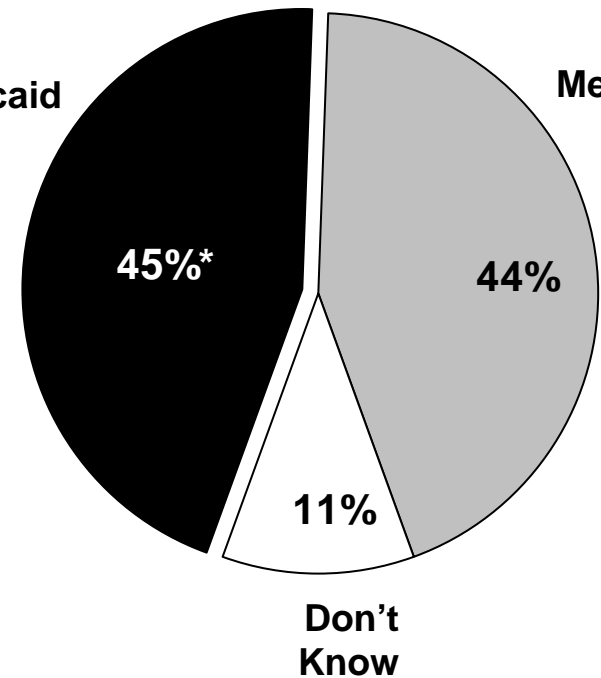

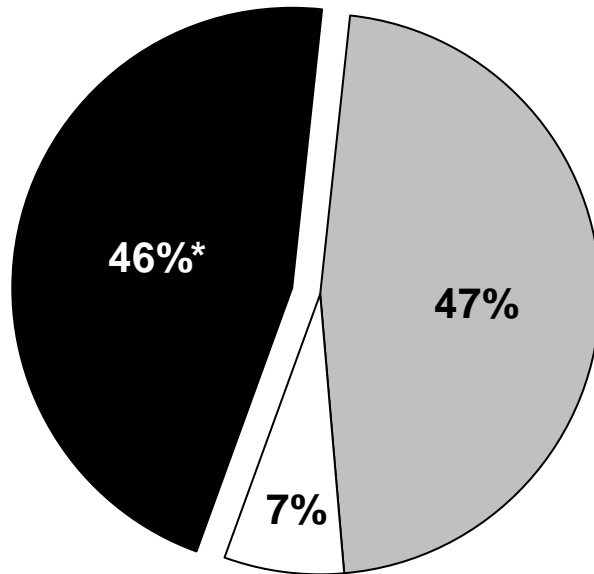

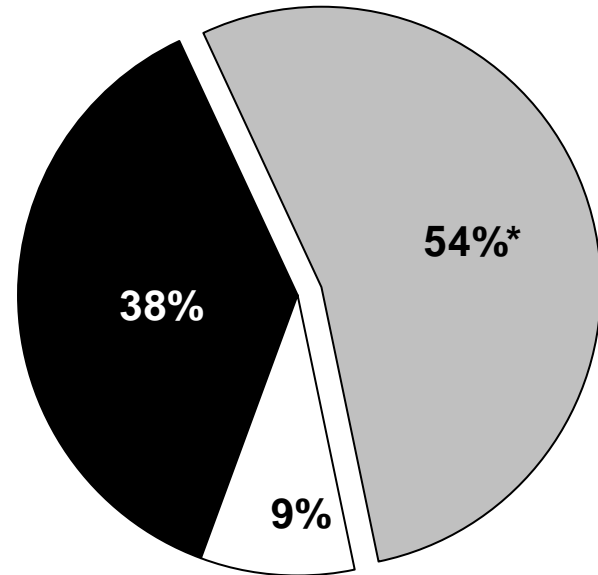

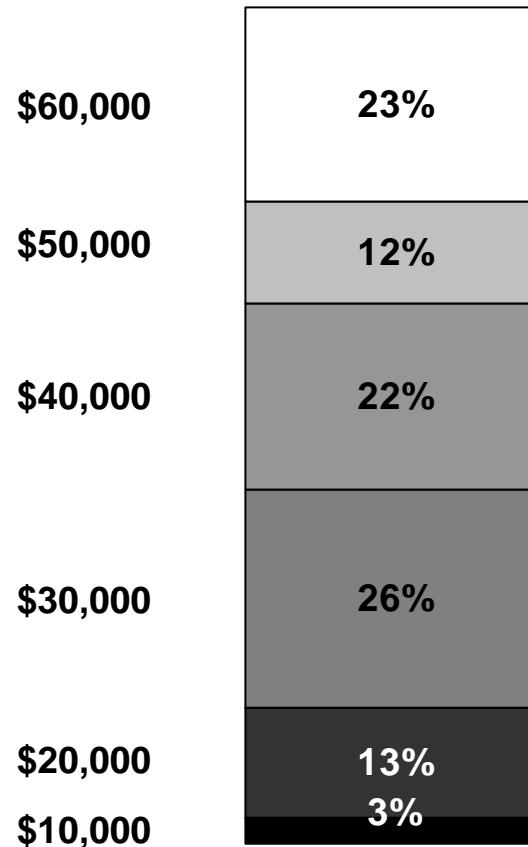
