## METHODOLOGY

*Sex Laws: Youth Opinion on Sexual Health Issues in the 2000 Election* reports on the results of a national random sample telephone survey of 603 adults ages 18-24. The questionnaire was designed and analyzed by staff at the Henry J. Kaiser Family Foundation, MTV: Music Television and Princeton Survey Research Associates (PSRA), and was conducted by PSRA July 5-17, 2000. The margin of error is plus or minus 4 percent.
