

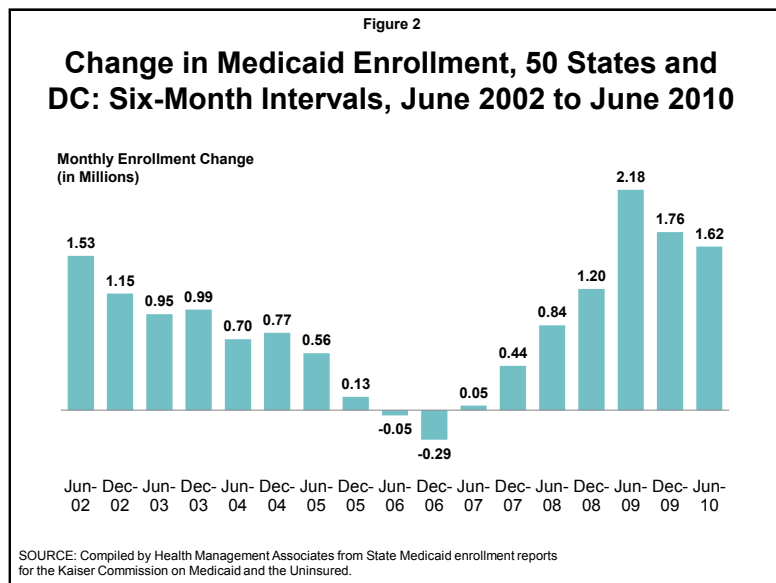
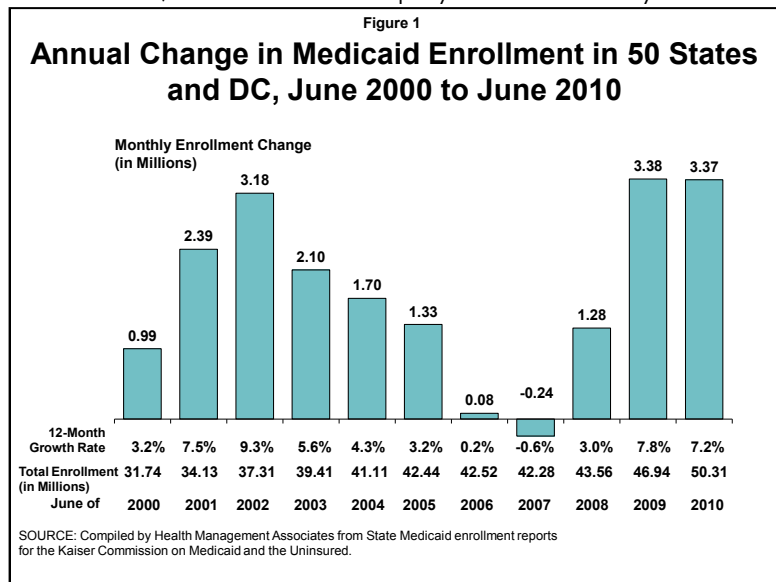

Medicaid Enrollment: June 2010 Data Snapshot

Medicaid enrollment increased nationwide by 7.2 percent, or 3.37 million, between June 2009 and June 2010, exceeding 50 million enrollees for the first time in the program's history (Figure 1). Medicaid enrollment has grown by 7.6 million (17.8 percent) since the start of the recession in December 2007. Between that month and June 2010, the nation's unemployment rate nearly doubled from 5.0 percent to 9.5 percent. Many Americans lost jobs, incomes, and access to affordable employer coverage. Consequently, demand for Medicaid grew. Medicaid enrollment hit a record high of 50.3 million in June 2010. Millions more who did not qualify under their state's existing Medicaid eligibility criteria likely joined the ranks of America's now 50 million uninsured.

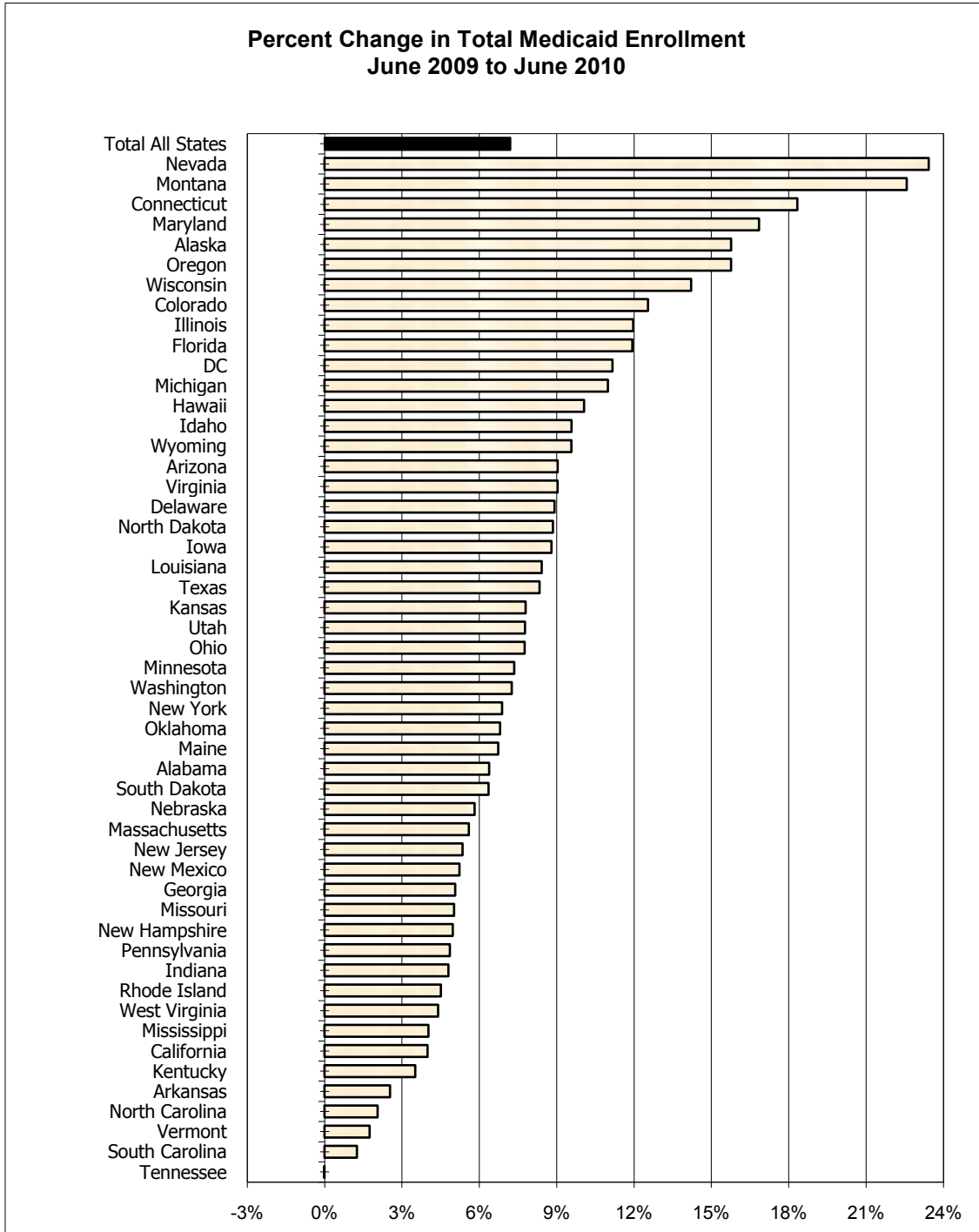
Growth in monthly enrollment peaked during the first six months of 2009 when 2.18 million were added to the program. By comparison, 1.62 million were added to Medicaid in the first six months of 2010 (Figure 2).

Cross State Trends. Consistent with the national trend, Medicaid enrollment increased in every state except Tennessee¹ between June 2009 and June 2010. The size of the annual increase in Medicaid enrollment varied considerably across states. Ten states accounted for over 60 percent of the total growth in Medicaid between June 2009 and 2010 (New York, Florida, California, Illinois, Texas, Michigan, Ohio, Wisconsin, Maryland and Arizona). Many of these states are large states, so even with smaller percentage changes, they account for a lot of the total increase. Between June 2009 and June 2010, 13 states experienced double-digit percentage growth. (Figure 3, Tables 1, 2).

Children vs. Adults. This report collects information about children compared to all adults enrolled in Medicaid (including those who are aged or disabled). Families (children and their parents) are typically affected more by changes in the economy, but because Medicaid eligibility is considerably broader for children than for adults, children account for a larger share of enrollment and enrollment growth. From June 2009 to June 2010, 54 percent of the growth in Medicaid enrollment occurred among children (1.8 million of the 3.4 million total growth, see Table 3). Ten states (Texas, Florida, Illinois, California, New York, Ohio, Arizona, Wisconsin, Georgia and Michigan) accounted for over half (57 percent) of the increase in the number of children from June 2009 to June 2010. Montana, Nevada, Utah, Oregon and Alaska had the highest rates of growth for children (at or above 18 percent) from June 2009 to June 2010. Ten states accounted for over two-thirds (67 percent) of the increase in the number of adults enrolled in Medicaid from June 2009 to June 2010 (New York, California, Michigan, Florida, Illinois, Ohio, Wisconsin, Connecticut, Maryland and Louisiana). Connecticut, Montana, Maryland, Louisiana, DC and Colorado experienced the highest rates of growth for adults over the same period (above 15 percent).

Aged and Disabled. For this report, 44 states and DC were able to provide the number of Medicaid enrollees who were aged or living with disabilities, including those “dual eligibles” covered by Medicare. Although less sensitive to changes in economic conditions, enrollment among the aged and disabled has risen consistently since 2000 reaching 12.1 million for 44 states in June 2010. Over the last decade, Aged and Disabled enrollment growth averaged 2.7 percent, and rose by 3.3 percent between June 2009 and June 2010 nationally, with increases in all but three states (Table 4). This growth is significant given the higher health care needs and expenditures associated with this population who account for 67 percent (FY 2007) of total Medicaid spending, although they represent just 25 percent of total Medicaid enrollment. For the June 2009 to June 2010 period, 5 states (Florida, New York, California, Texas and Ohio) accounted for nearly half (49 percent) of the increased enrollment for the aged and disabled. DC experienced the highest growth rate (19.5 percent) for this population over the same period; Nevada was next with a growth rate of 8.0 percent.

Conclusion. As the economy improves and the unemployment rate declines there will be less pressure on enrollment growth. During the last recession, enrollment growth peaked in 2002 at 9.3 percent. Enrollment growth continued to taper until 2007 with the start of another economic downturn. This time, it appears that Medicaid enrollment growth may have peaked at 7.8 percent in the period from June 2008 to June 2009 and then declined to 7.2 percent from June 2009 and June 2010. But even with slowing of the growth rate, Medicaid hit its largest ever enrollment total—exceeding 50 million in June 2010. Federal support and eligibility protections provided through fiscal stimulus helped to preserve Medicaid coverage and stem increases in the uninsured. Financing for an enhanced Medicaid match rate was extended through June 2011 and the Affordable Care Act extends these eligibility protections through 2014, when Medicaid eligibility will expand to poor adults as well as children. However, with states still struggling from the impact of the recession and the scheduled expiration of federal assistance, financing and maintaining the program will continue to be a challenge.

These June 2010 enrollment data provide the latest available snapshot of Medicaid trends nationally and across the states.
