JOSEPH R. ANTOS, Ph.D.

Joseph Antos is the Wilson H. Taylor Scholar in Health Care and Retirement Policy at AEI and an adjunct professor at the University of North Carolina at Chapel Hill School of Public Health. He was the assistant director for health and human resources, the division providing Congress with analyses of proposed changes to federal programs and policies in areas such as health, income security, education, employment, and housing, at the Congressional Budget Office. Mr. Antos was the director of the Office of Research and Demonstrations and deputy director of the Office of the Actuary at the Health Care Financing Administration. He was the deputy chief of staff and the principal deputy assistant secretary for management and budget at the Department of Health and Human Services.

BARBARA B. KENNELLY

Barbara B. Kennelly has spent 23 years in elected public office at local, state and federal levels, including 17 years as a member of the U.S. Congress. A former ranking member of the House Ways and Means Committee's Subcommittee on Social Security, Mrs. Kennelly was the first woman to serve as Chief Majority Whip and on the House Committee on Intelligence. She was also Vice Chair of the House Democratic Caucus. Throughout her career, Mrs. Kennelly has advocated for Social Security, Medicare and other health and retirement issues. After leaving Congress, she served as Associate Commissioner of the Social Security Administration. Mrs. Kennelly was appointed to the Policy Committee for the 2005 White House Conference on Aging.

JIM MAYS

James Mays is Vice President for Management of Actuarial Research Corporation. Since joining ARC in 1979, his major areas of analysis have included comprehensive national health insurance proposals, incremental private insurance expansion options, health insurance rating reform, Medicare prescription drug coverage and comprehensive Medicare reform. In the past dozen years, he has also worked outside the United States with the World Bank, the International Labor Organization, and WHO in 14 countries on 5 continents on health financing reform issues. He has a B.A. in mathematics from Bridgewater College (1975) and an M.S. in computer science from the University of Virginia (1979).

MARILYN MOON, Ph.D.

Marilyn Moon is Vice President and Director of the Health Program at the American Institutes for Research. A nationally recognized expert on Medicare, she has also served as a Senior Fellow at the Urban Institute and as a public trustee for the Social Security and Medicare trust funds. Marilyn Moon has written extensively on health policy, both for the elderly and the population in general, and on social insurance issues. From 1993 to 2000, Moon also wrote a periodic column for the *Washington Post* on health reform and health coverage issues. She has served on a number of boards for non-profit organizations and is currently President of the board of the Medicare Rights Center. Moon earned a Ph.D. in economics from the University of Wisconsin--Madison. Previously, she was an associate professor of economics at the University of Wisconsin-Milwaukee, a senior analyst at the Congressional Budget Office, and the founding Director of the Public Policy Institute of the American Association of Retired Persons.

TRICIA NEUMAN, Sc.D.

Patricia Neuman is a vice president of the Henry J. Kaiser Family Foundation and is Director of the foundation's Medicare Policy Project. She is also an adjunct Associate Professor in the Department of Health Policy and Management at the School of Hygiene and Public Health of the Johns Hopkins University. Dr. Neuman is widely regarded as an expert on Medicare policy issues. She has published numerous articles on topics related to health coverage and financing for the Medicare population, and has been invited several times to present expert testimony before Congressional committees. Dr. Neuman received a Doctorate of Science degree in health policy and management and a Masters of Science degree in health finance and management from the Johns Hopkins School of Public Health in Baltimore, Maryland. She received her Bachelor's degree from Wesleyan University in Middletown, Connecticut.

DIANE ROWLAND, Sc.D.

Diana Rowland is the Executive Vice President of the Henry J. Kaiser Family Foundation and the Executive Director of the Kaiser Commission on Medicaid and the Uninsured. She is also an adjunct Professor in the Department of Health Policy and Management at the School of Hygiene and Public Health of the Johns Hopkins University. Dr. Rowland is a noted authority on health policy, Medicare and Medicaid, and health care for low-income, elderly, and disadvantaged populations and has published widely on these subjects. Her federal health policy experience includes service on the staff of the Subcommittee on Health and the Environment of the Committee on Energy and Commerce in the House of Representatives of the U.S. Congress, as well as senior health policy positions in the Department of Health and Human Services in the Office of the Secretary and the Health Care Financing Administration. Dr. Rowland holds a Bachelor's degree from Wellesley College, a Masters in Public Administration from the University of California at Los Angeles and a Doctor of Science in health policy and management from the Johns Hopkins University.
