Selected Findings on the Medicare Drug Law

January 2005

Methodology

The Kaiser Family Foundation *Health Poll Report Survey* was designed and analyzed by researchers at the Kaiser Family Foundation. Fieldwork was conducted by telephone by Princeton Survey Research Associates International between December 2 and December 5, 2004, among a nationally representative random sample of 1,203 adults ages 18 and older, including 237 adults ages 65 and older and 953 adults ages 18 to 64.

The margin of sampling error for the survey is plus or minus 3 percentage points for total respondents; for respondents ages 65 and older it is plus or minus 7 percentage points; and for respondents ages 18 to 64 it is plus or minus 4 percentage points. For results based on smaller subsets of respondents the margin of sampling error is higher. Note that sampling error is only one of many potential sources of error in this or any other public opinion poll.

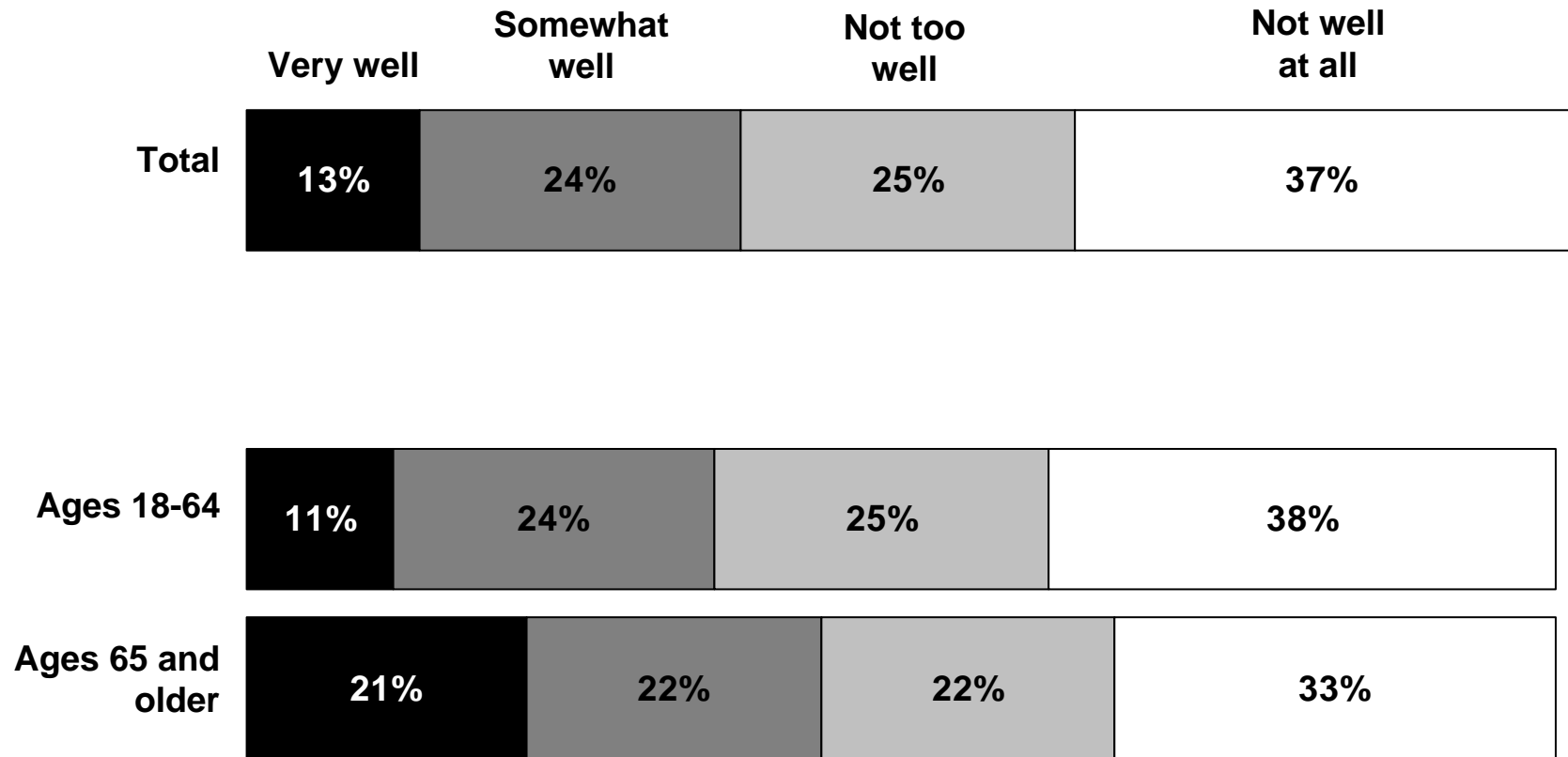

- April 2004: Kaiser Family Foundation *Health Poll Report Survey*, conducted Apr. 1-5, 2004 among a nationally representative random sample of 1,201 adults ages 18 and older, including 262 adults ages 65 and older.
- June 2004: Kaiser Family Foundation/Harvard School of Public Health *Views of the New Medicare Drug Law: A Survey of People on Medicare*, conducted June 16-July 21, 2004 among a nationally representative random sample of 973 adults ages 65 and older.
- October 2004: Kaiser Family Foundation *Health Poll Report Survey*, conducted Oct. 14-17, 2004 among a nationally representative random sample of 1,202 adults ages 18 and older, including 264 adults ages 65 and older.

Percentages may not always add up to 100% due to rounding.

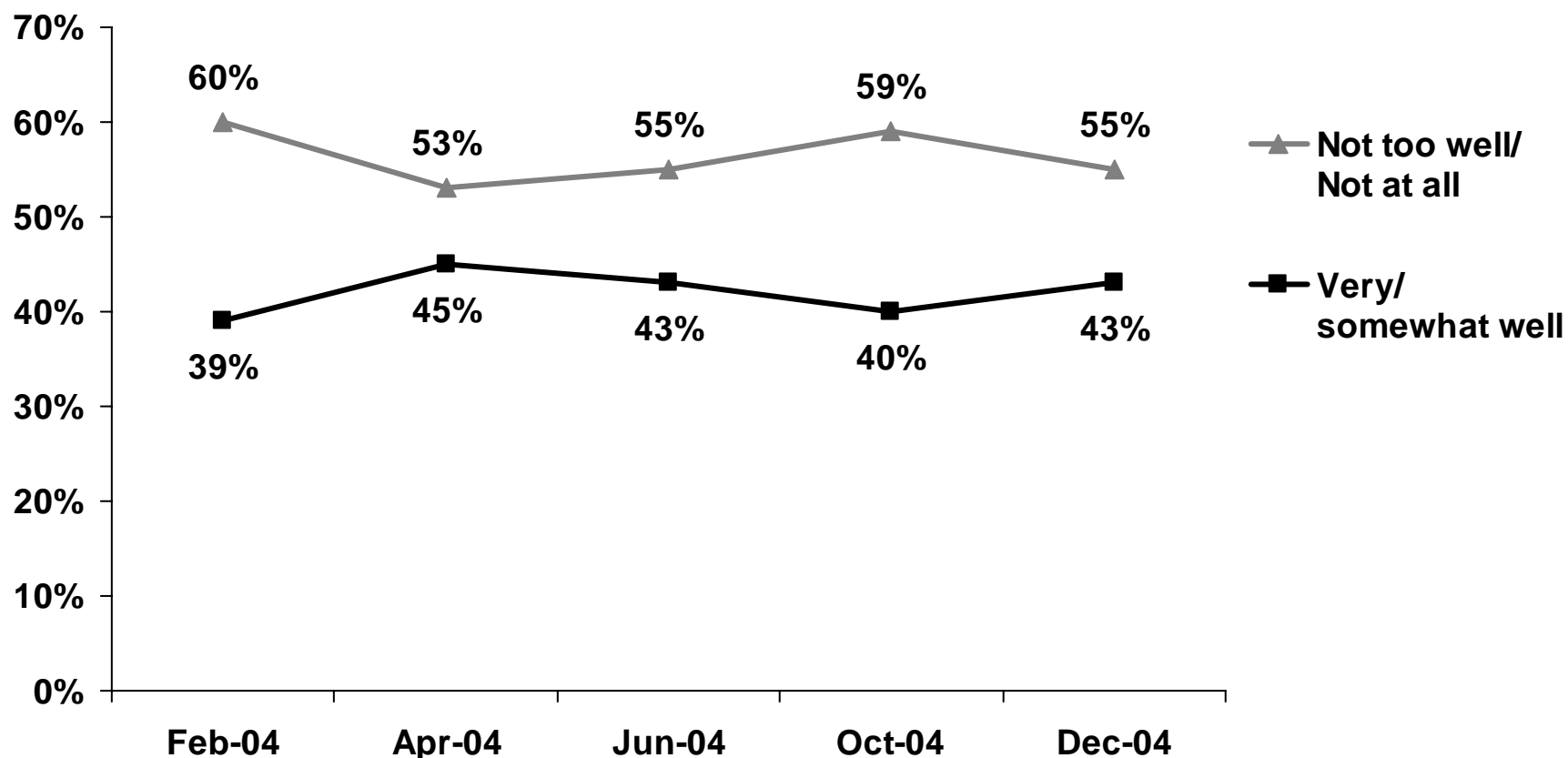

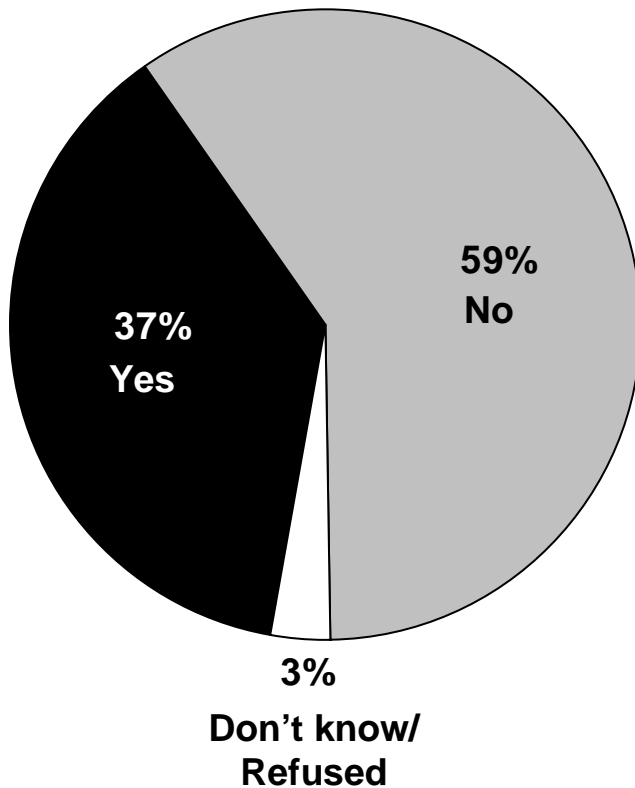

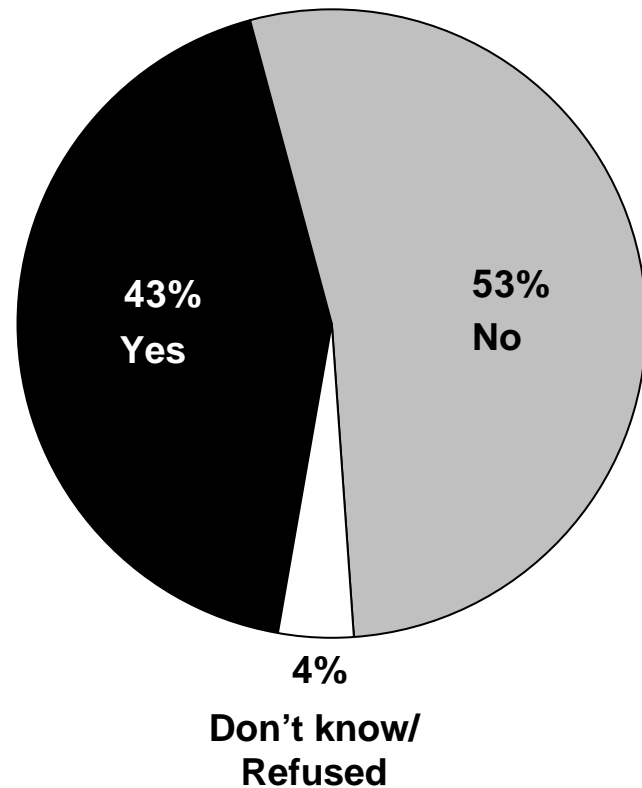
Seniors' Understanding Of New Medicare Law

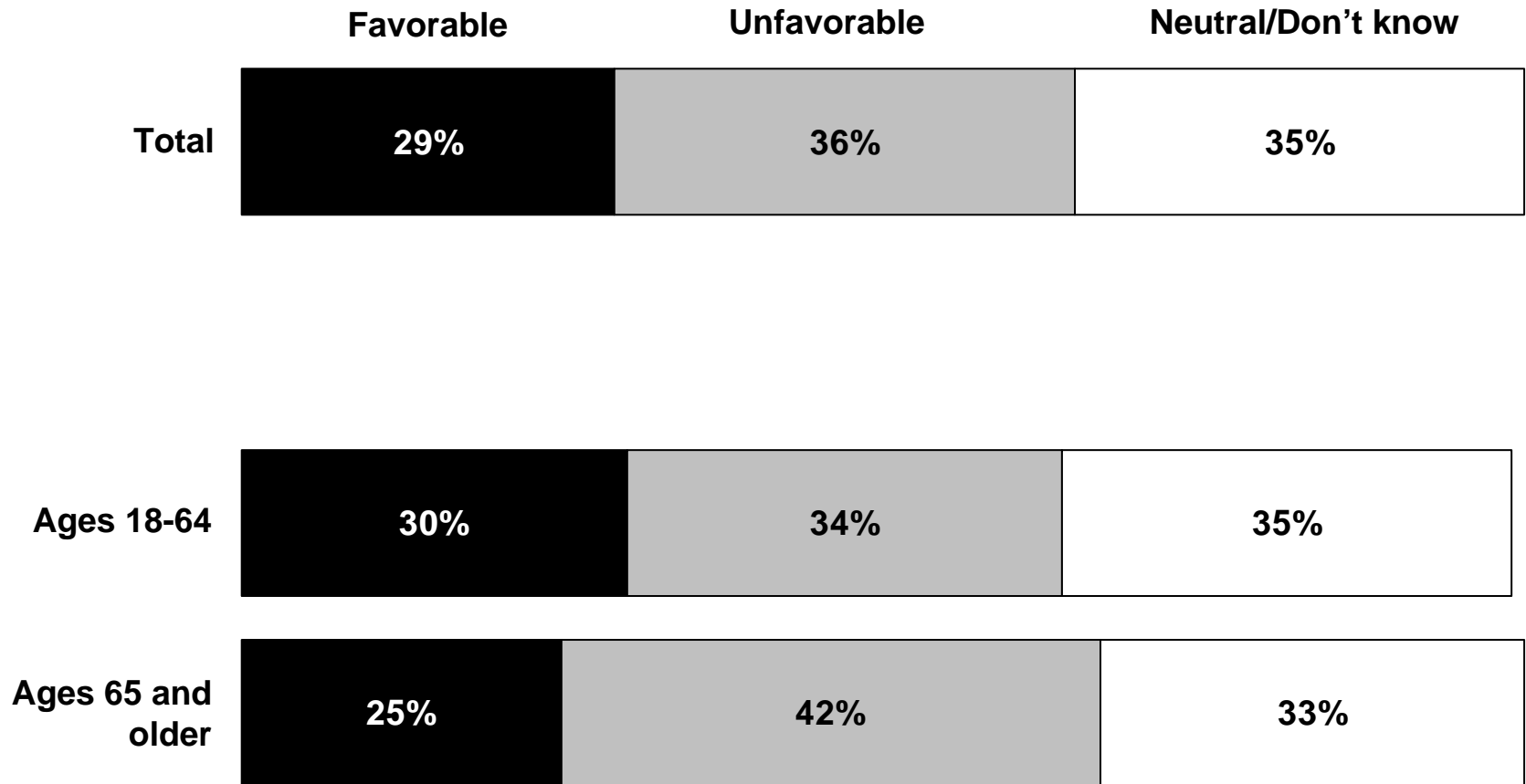

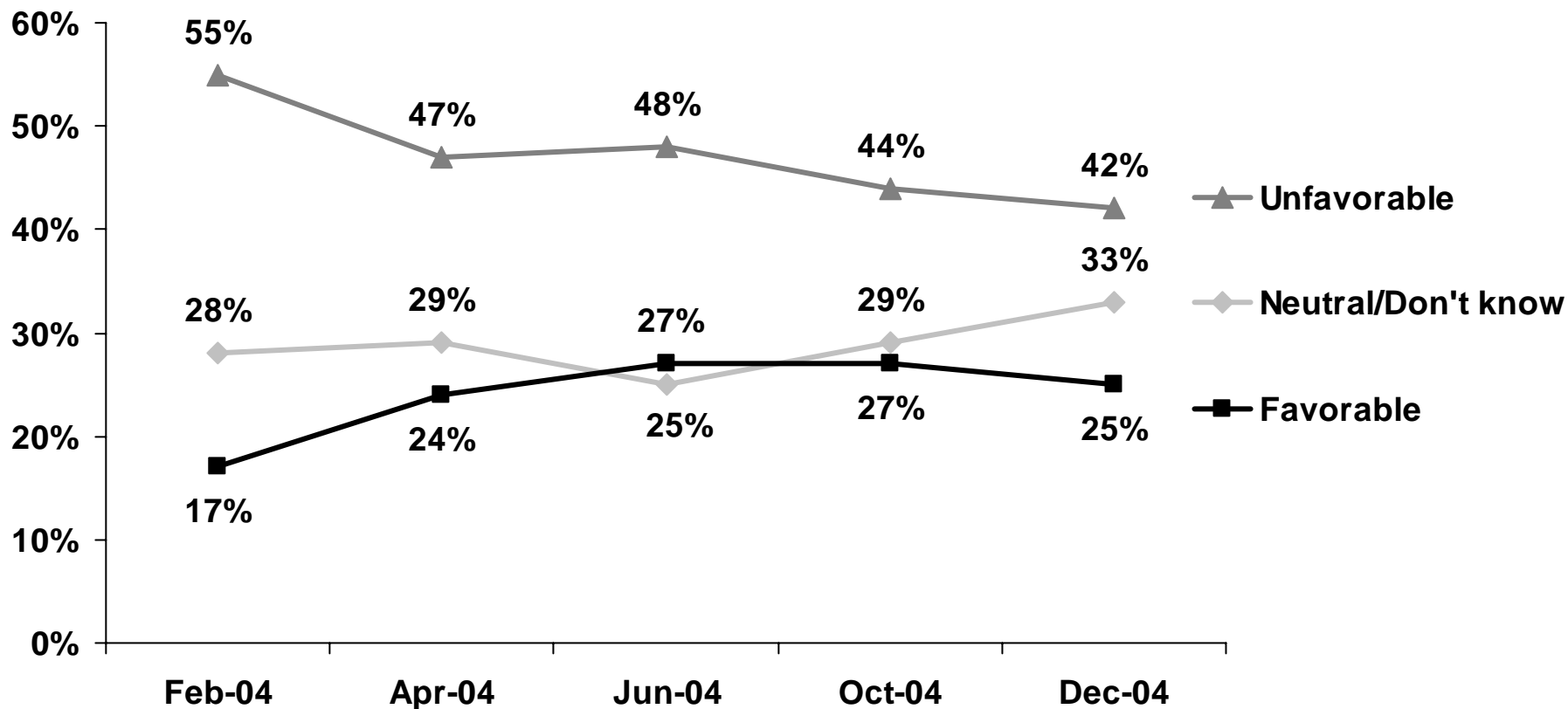
Impressions of New Medicare Law

Seniors' Impressions of New Medicare Law - Trend

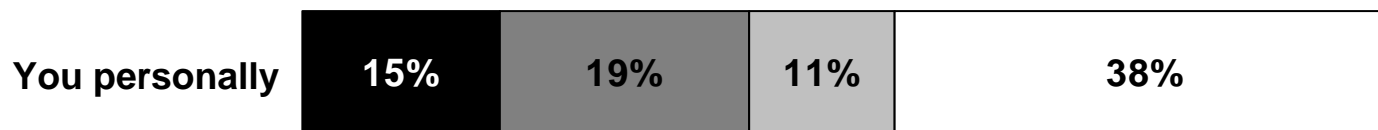
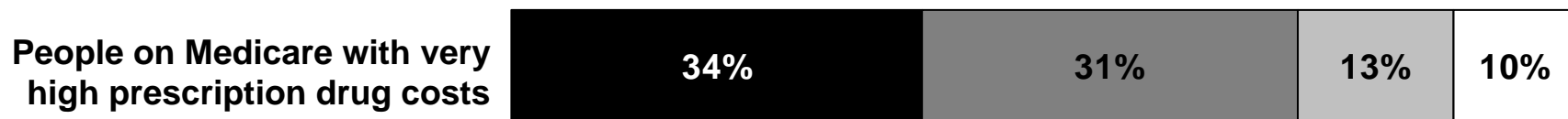
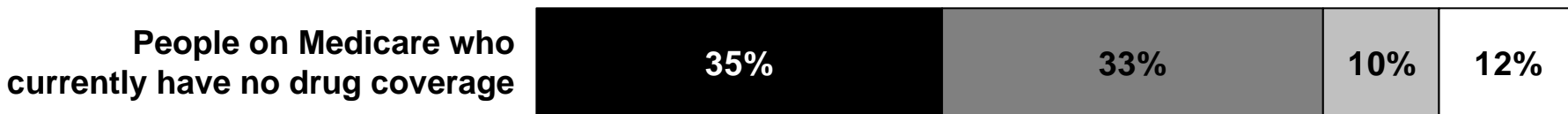

AMONG SENIORS: How helpful do you think the new Medicare law will be for the following people?

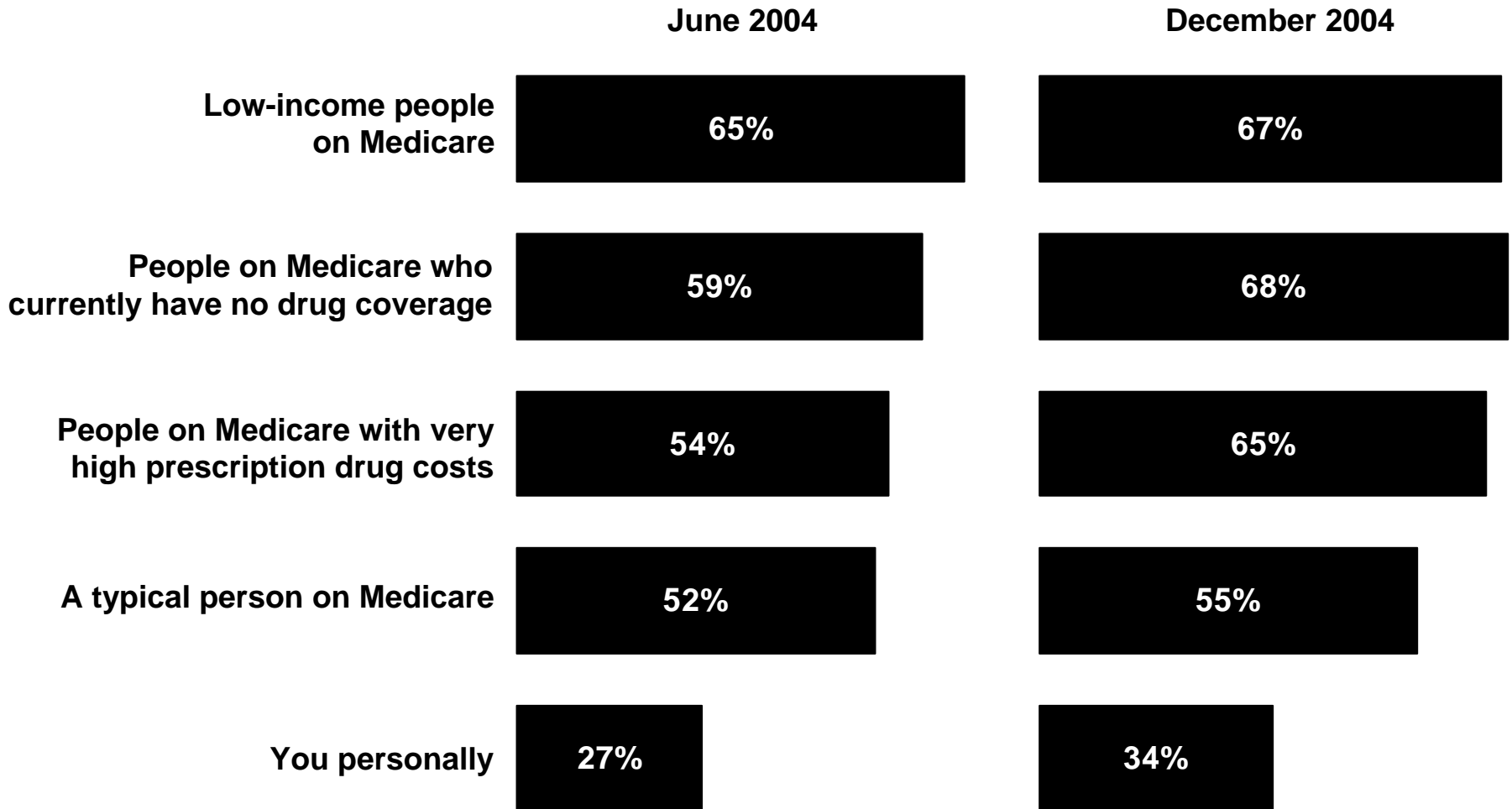
Very helpful

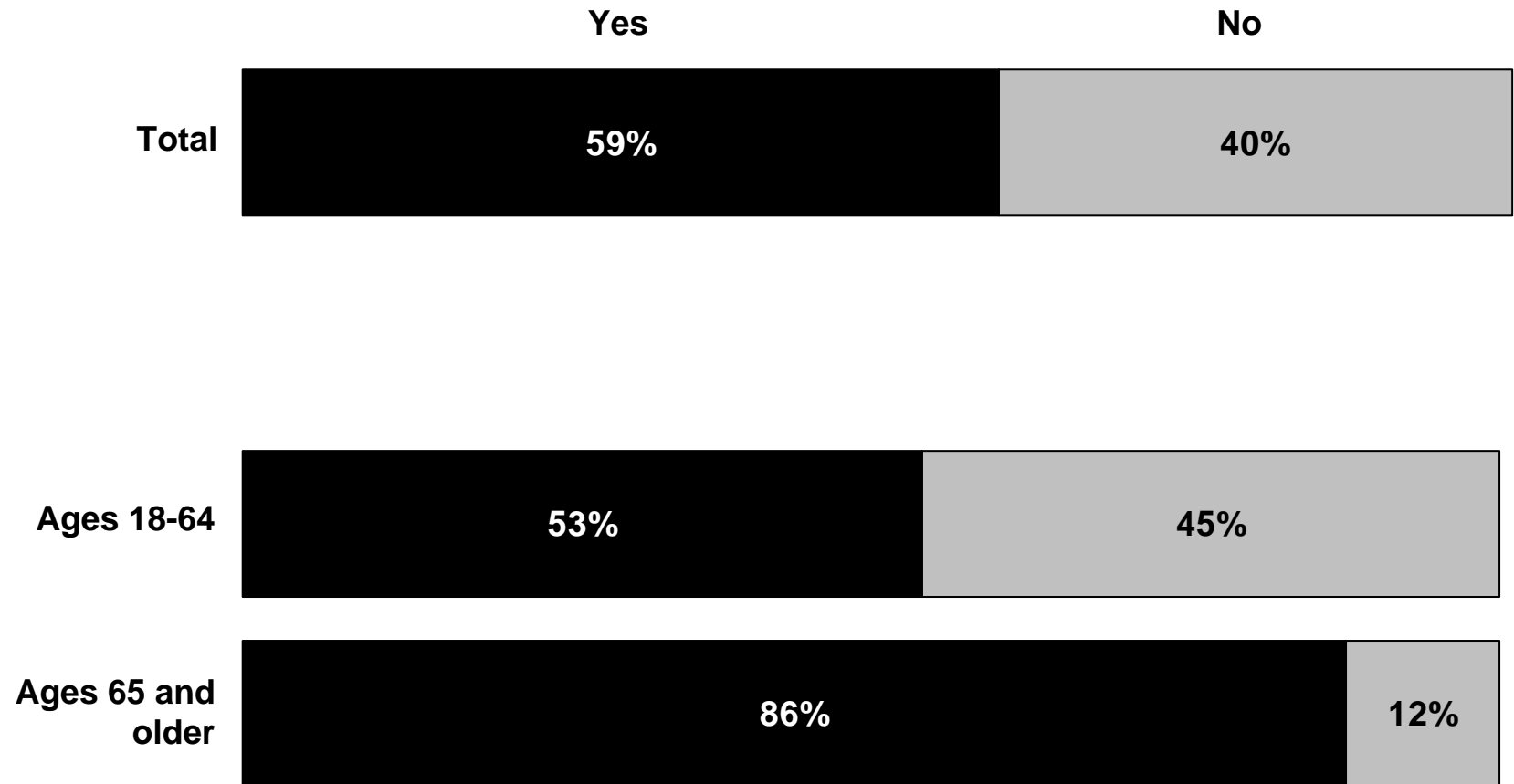
Perceived Helpfulness of New Medicare Law - Trend

Medicare began offering prescription drug discount cards to people on Medicare in June of this year. Were you aware of this Medicare-approved drug discount card program, or not?

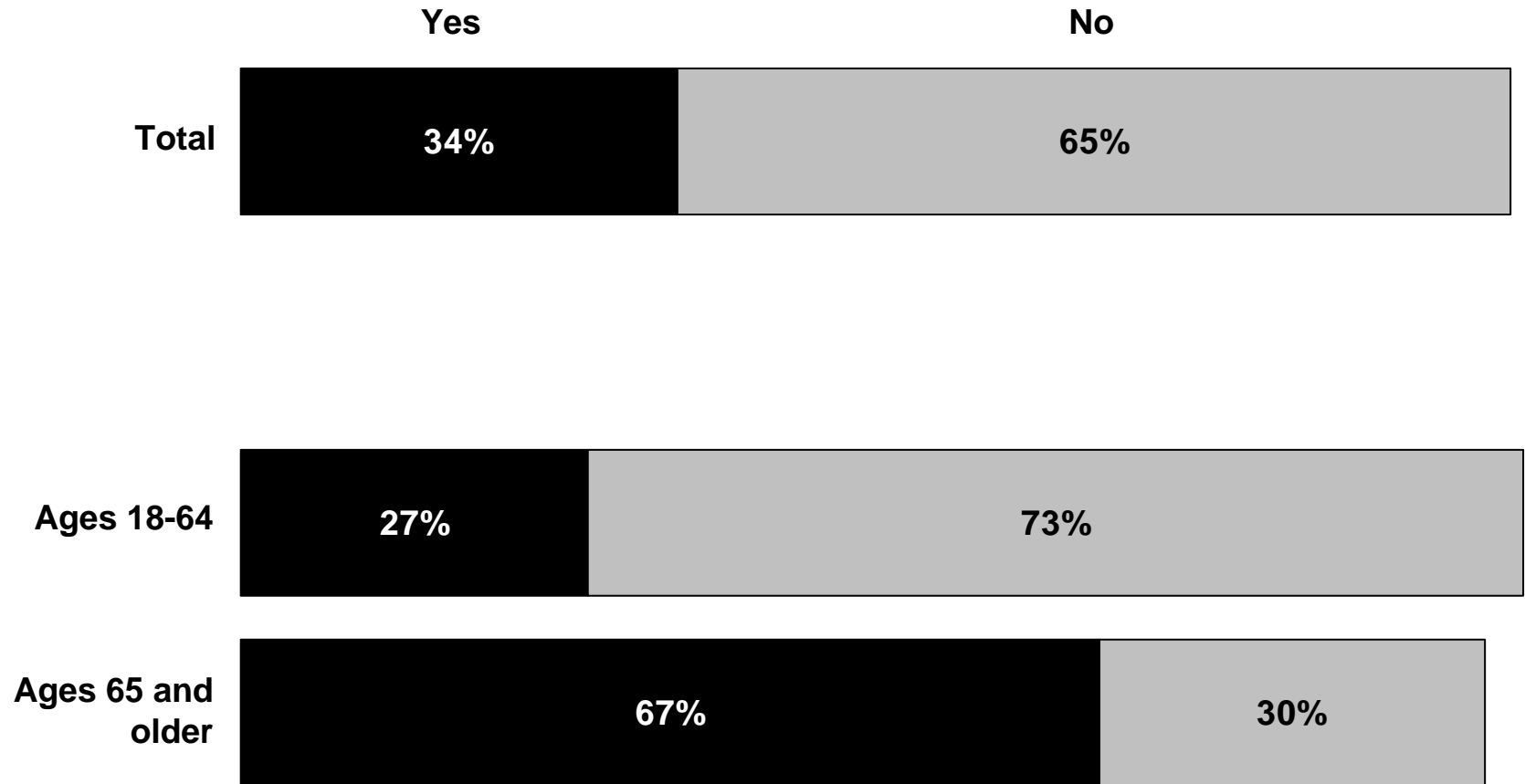

Medicare began offering a \$600 subsidy on the cost of prescription drugs to people with very low incomes. Were you aware of this \$600 subsidy, or not?



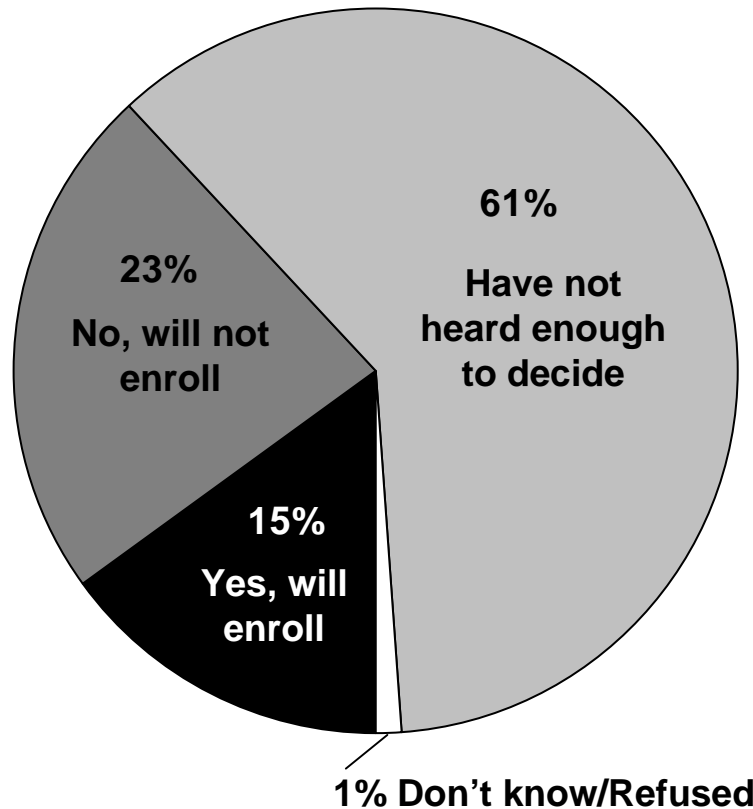

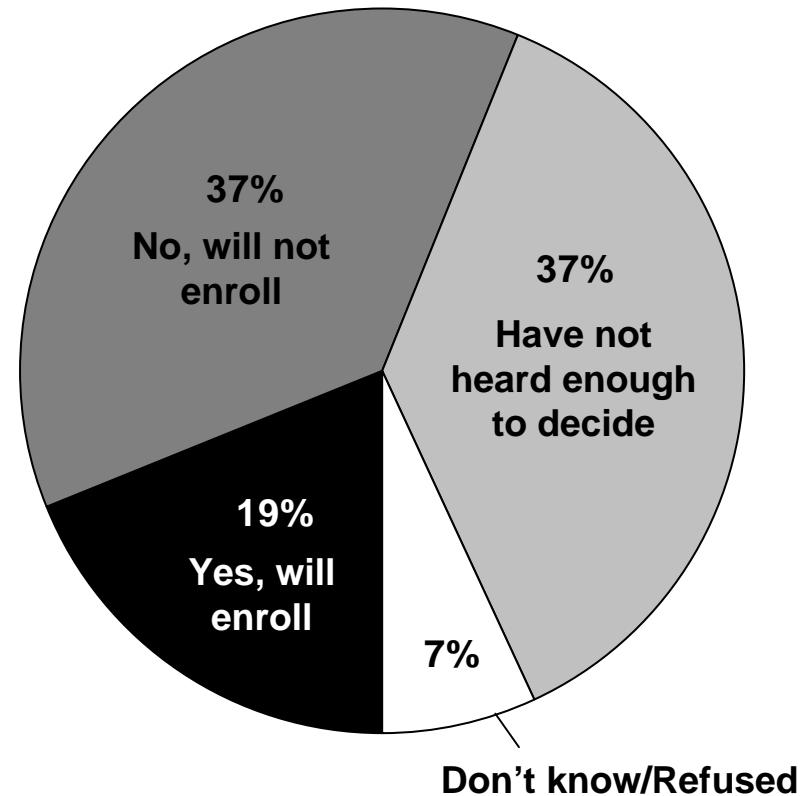
Reported Plans for Enrollment in 2006 Benefit

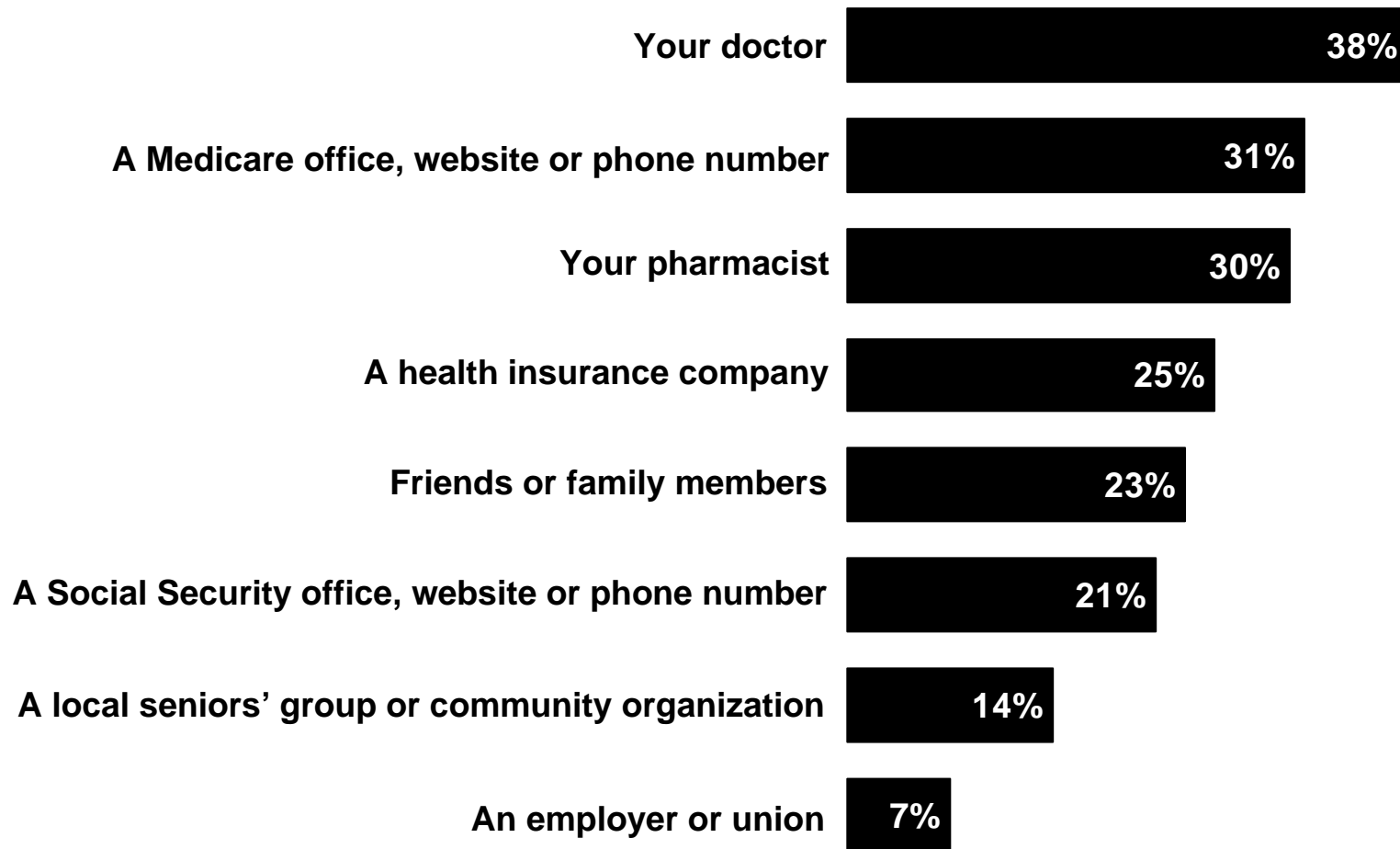

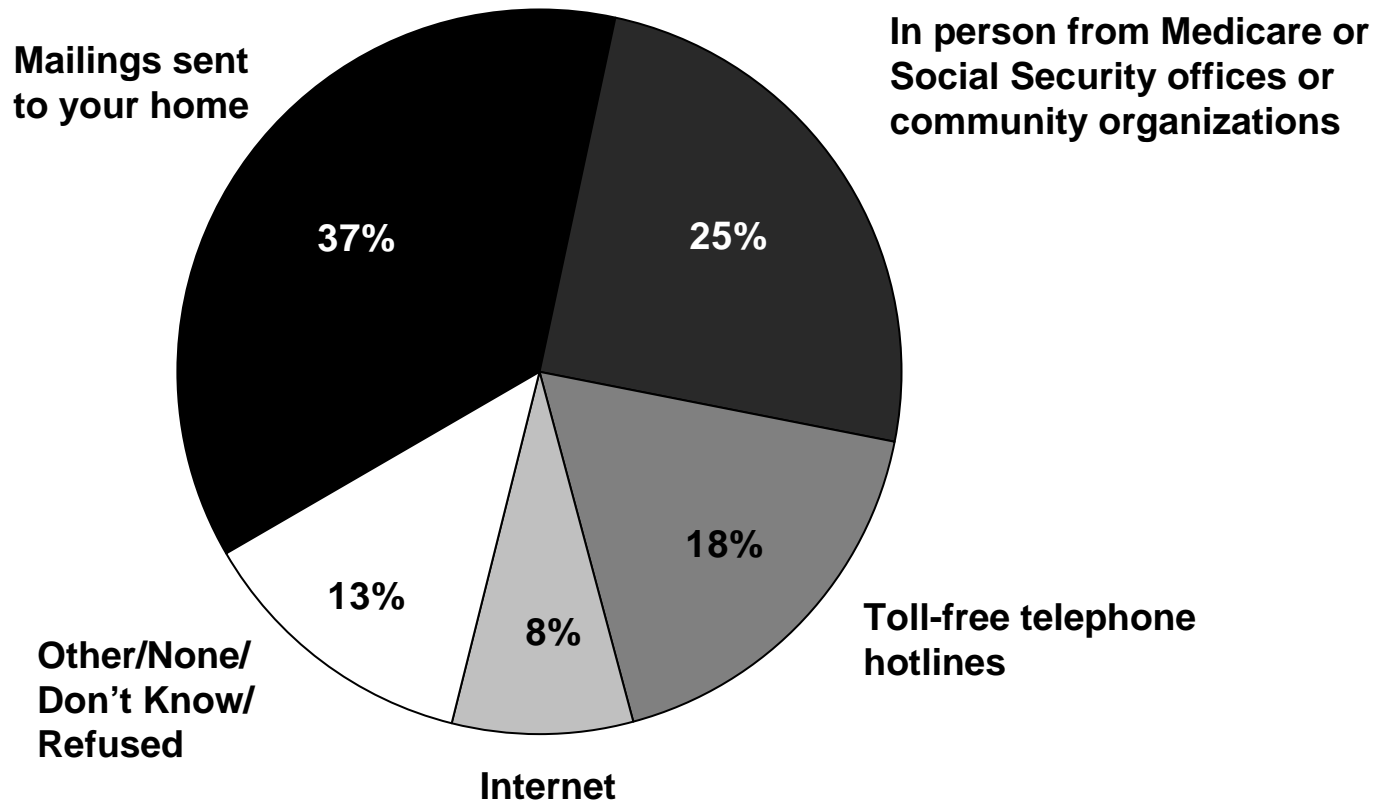
Sources For Information About Medicare Drug Plan

AMONG SENIORS: Percent who say they would be very likely to turn to each of the following for help in deciding whether to enroll in a Medicare drug plan...



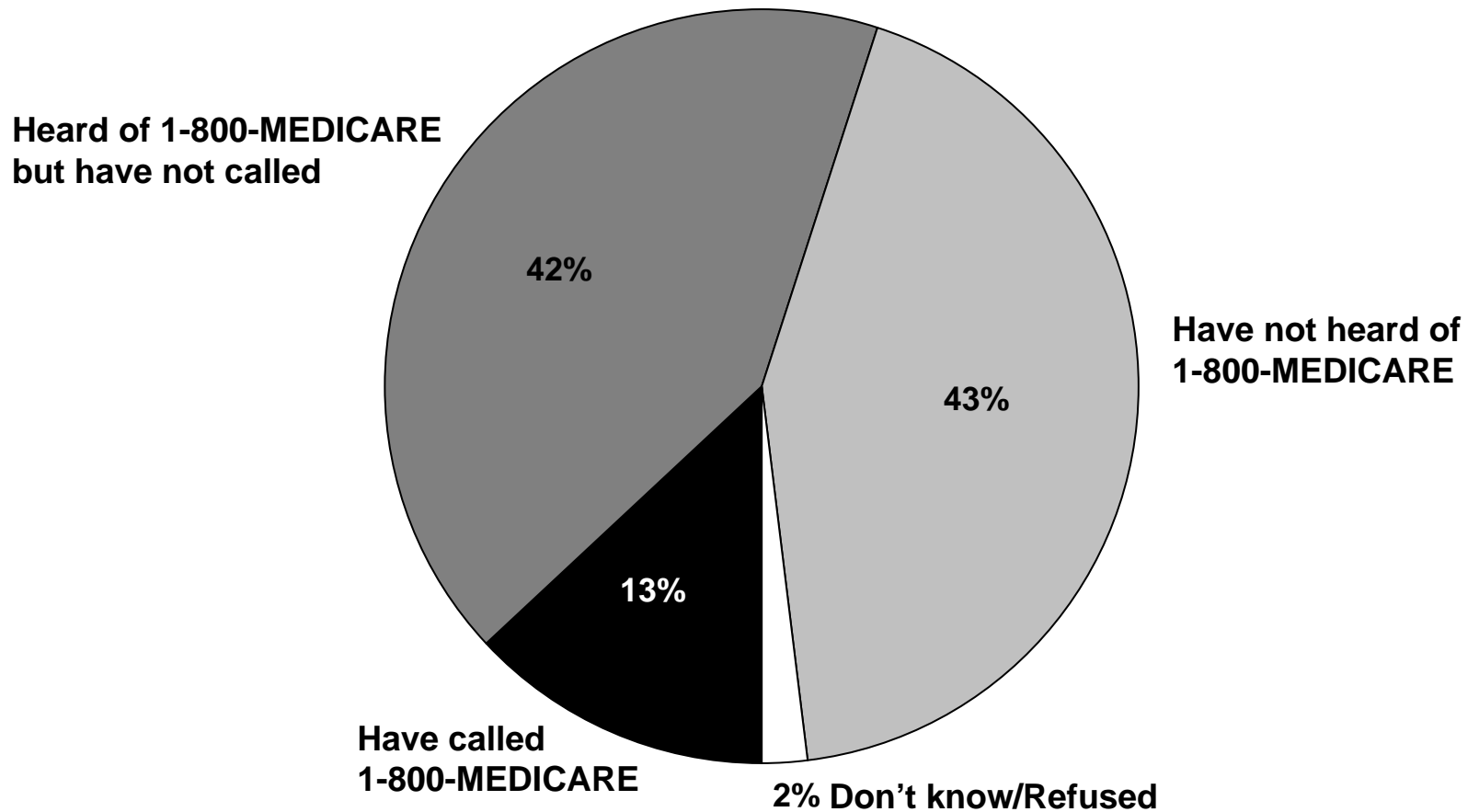
Preferred Way to Get Information

AMONG SENIORS: In which of the following ways would you **MOST** like to get information about Medicare and the new drug benefit?



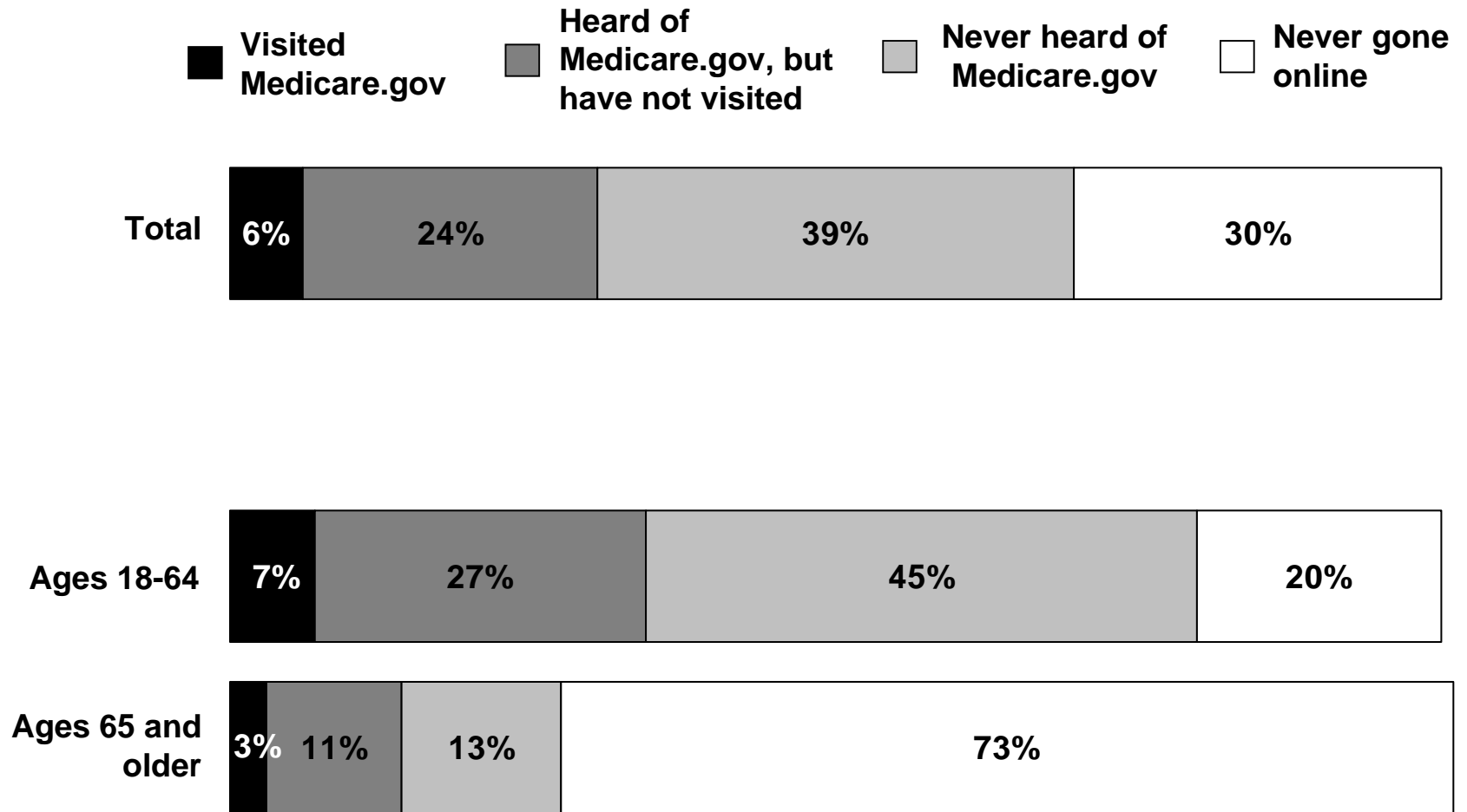
Reported Awareness and Use of 1-800-Medicare

AMONG SENIORS: Percent who say they have heard of/called 1-800-MEDICARE...



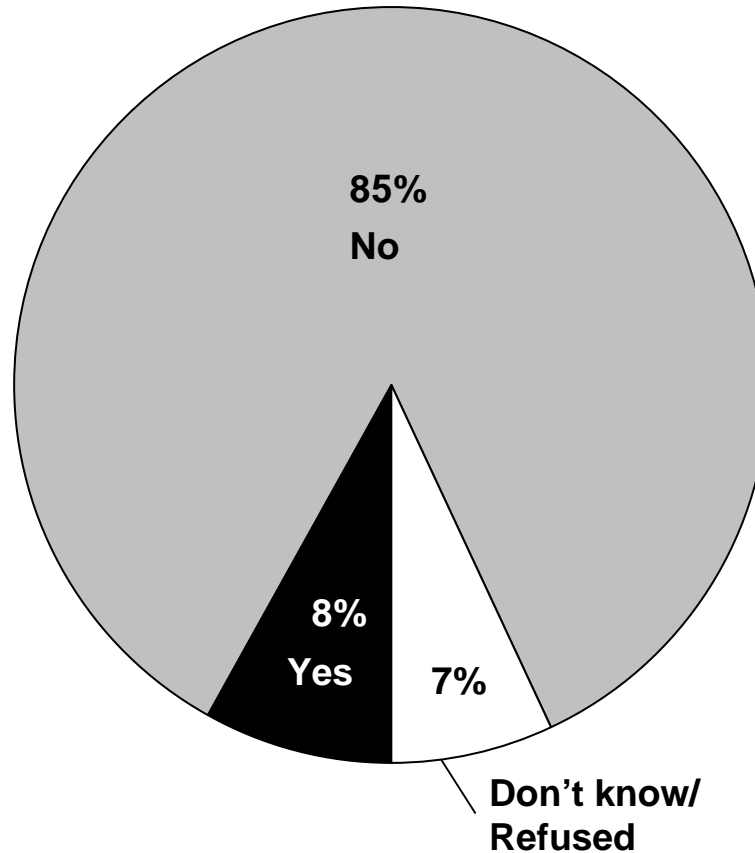

Percent who say they have heard of/visited Medicare.gov...



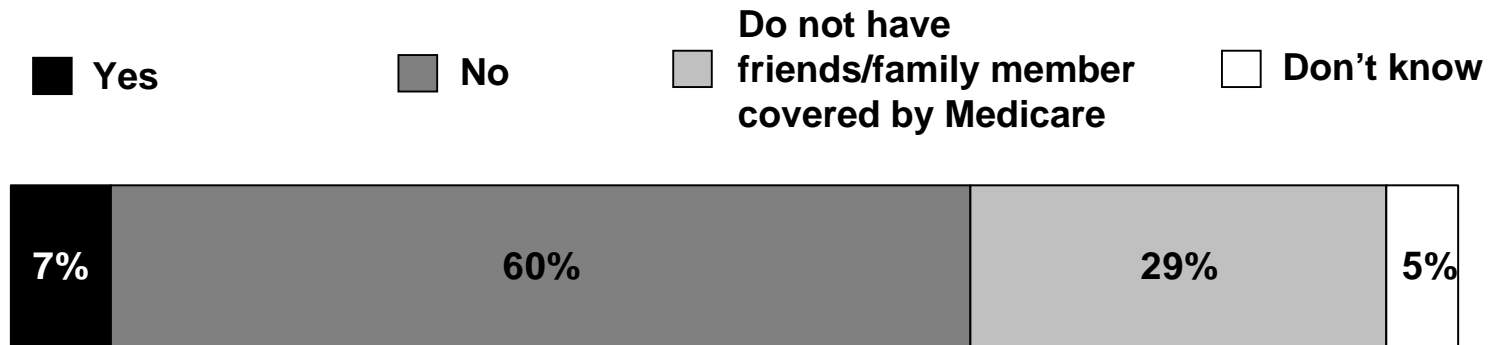
Seniors' Reported Assistance Getting Medicare Information Online

AMONG SENIORS: As far as you know, has a friend or family member ever visited an Internet web site on your behalf for information about Medicare, or not?

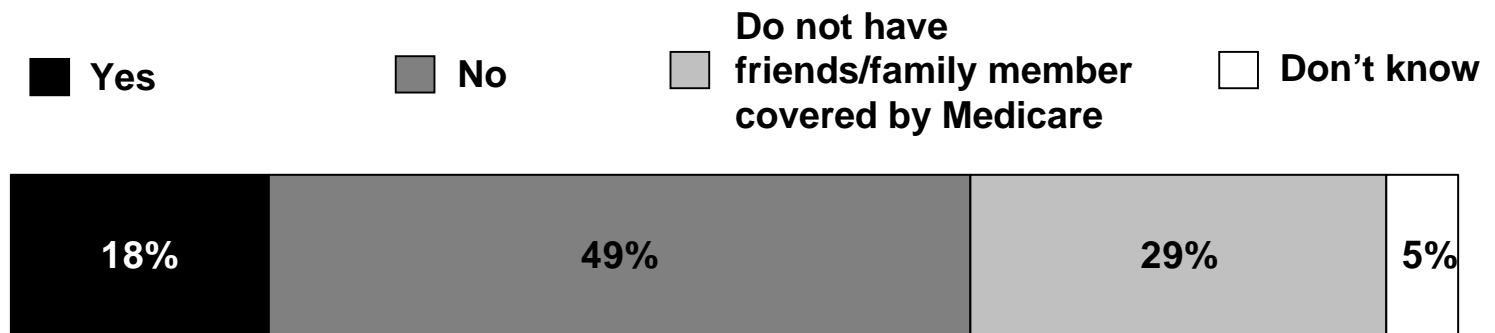


Younger Adults Assisting Elderly in Getting Medicare Information
