

The Medicaid EHR Incentive Program is a voluntary program established by Congress, administered individually by each State and territory. While we currently estimate that every State will have an Incentive Program in the future, the preparation for the program varies from state to state. Below is the estimated date each State intends to begin accepting registrations for its Medicaid EHR Incentive Program. These dates are provided to CMS by the States, and this list is updated monthly. Even States that are listed as “Unknown” are progressing toward program launch; however, they have not provided CMS with an estimated launch date. This list also includes the following information for each State: the date incentive payments are first distributed, the end date of the attestation grace period for 2011 for eligible hospitals (EHs) and eligible professionals (EPs), and the date when Meaningful Use (MU) attestations will be accepted.
