ASSEMBLY BILL

An act to add Section 1367.655 to the Health and Safety Code, and to add Section 10123.205 to the Insurance Code, relating to health care coverage.

LEGISLATIVE COUNSEL'S DIGEST

AB 1000, as amended, Perea. Health care coverage: cancer treatment.

Existing law, the Knox-Keene Health Care Service Plan Act of 1975, provides for the licensure and regulation of health care service plans by the Department of Managed Health Care and makes a willful violation of the act a crime. Existing law also provides for the regulation of health insurers by the Department of Insurance. Existing law requires health care service plan contracts and health insurance policies to provide coverage for all generally medically accepted cancer screening tests and requires those contracts and policies to also provide coverage for the treatment of breast cancer. Existing law imposes various requirements on contracts and policies that cover prescription drug benefits.

This bill would prohibit a health care service plan contract and a health insurance policy *issued, amended, or renewed on or after July 1, 2013*, that provides coverage for cancer chemotherapy treatment from requiring a higher copayment, deductible, or coinsurance amount for a prescribed, orally administered anticancer medication than the health care service plan or health insurer requires for an intravenously administered or injected cancer medication, as specified. The bill would prohibit a health care service plan or a health insurer from being deemed to have complied with these provisions by increasing the copayment, deductible, or coinsurance amount for an intravenously administered or injected cancer chemotherapy agent. The bill would specify that its provisions do not apply to a health care service plan contract or health insurance policy that does not provide outpatient prescription drug coverage or to a health care benefit plan, contract, or policy with the Board of Administration of the Public Employees’ Retirement System. The bill would also provide that no benefits are required to be provided under its provisions that exceed the essential health benefits that will be required under specified federal law.

Because a willful violation of the bill’s requirements relative to health care service plans would be a crime, the bill would impose a state-mandated local program.

The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that no reimbursement is required by this act for a specified reason.

32 a health insurance policy issued, amended, or renewed on or after
33 ~~January~~ *July* 1, 2013, that provides coverage for cancer
34 chemotherapy treatment shall not require a higher copayment,
35 deductible, or coinsurance amount for a prescribed, orally
36 administered anticancer medication that is used to kill or slow the
37 growth of cancerous cells than the health insurer requires for an
38 intravenously administered or injected cancer medication,
39 regardless of formulation or benefit category determination by the
40 health insurer.

1 (b) A health insurer shall not be deemed to have complied with
2 this section by increasing the copayment, deductible, or coinsurance
3 amount for an intravenously administered or injected cancer
4 chemotherapy agent covered by the health insurer.

5 (c) Nothing in this section shall be interpreted to prohibit a
6 health insurer from requiring prior authorization or conducting
7 utilization review in approving coverage for any chemotherapy.

8 (d) This section shall not apply to a health insurance policy that
9 does not provide coverage for outpatient prescription drugs.

10 (e) This section shall not apply to a health care benefit plan or
11 policy entered into with the Board of Administration of the Public
12 Employees' Retirement System pursuant to the Public Employees'
13 Medical and Hospital Care Act (Part 5 (commencing with Section
14 22750) of Division 5 of Title 2 of the Government Code).

15 (f) Notwithstanding subdivision (a), as of the date that proposed
16 final rulemaking for essential health benefits is issued, this section
17 does not require any benefits to be provided that exceed the
18 essential health benefits that all health plans will be required by
19 federal regulations to provide under Section 1302(b) of the federal

23 SEC. 3. No reimbursement is required by this act pursuant to
24 Section 6 of Article XIII B of the California Constitution because
25 the only costs that may be incurred by a local agency or school
26 district will be incurred because this act creates a new crime or
27 infraction, eliminates a crime or infraction, or changes the penalty
28 for a crime or infraction, within the meaning of Section 17556 of
29 the Government Code, or changes the definition of a crime within
30 the meaning of Section 6 of Article XIII B of the California
31 Constitution.
