## POST-ELECTION SURVEY: PRIORITIES FOR THE 106<sup>th</sup> CONGRESS

National Topline

#### Methodology

The Kaiser Family Foundation/Harvard School of Public Health *Post-Election Survey* was designed and analyzed by researchers at the Kaiser Family Foundation and Harvard School of Public Health. The survey was conducted by telephone by Princeton Survey Research Associates with 1,501 adults nationwide, 18 years and older, including 751 voters in the November election, between November 4 and December 6, 1998. The margin of error for the voter sample is plus or minus 4 percentage points; for Democratic and Republican voter subsamples, the margin of error is  $\pm 6.5$  percentage points.

Notes: "Voted Rep" refers to respondents who voted for a Republican candidate and "Voted Dem" refers to those who voted for the Democratic candidate for Congress in the November election.

VOL means response was volunteered by respondent, rather than a response to an explicitly offered choice. Select questions were asked of a random half of the entire sample. These questions are identified by "Form 1" and "Form 2", indicating which half answered that particular question.

The survey is a product of the Kaiser-Harvard Program on the Public and Health/Social Policy.

Due to rounding, the percentages in each column may not always total exactly 100 percent.
